Area 4 Crime trends, priorities, and areas of focus during 2022 Q1:

Area 4 was re-organized covering beats 20 through 25 on 22 Jan 2022. Previously, Area 4 was comprised of beats 23 to 28. After a comprehensive review of the combined data, there was an increased ShotSpotter activity in the 2300 block of Humboldt Ave.

- o This address is a CRO project with Ofc. Smith oversees the community project.
- o In a review of the data and information from the community, it was determined a significant portion of the violence was being driven by one home in the 2300 block of Humboldt Ave.
- Ofc. Smith has contacted several residents in the neighborhood either in person or via email. The
 residents have made numerous complaints about the people coming and going from the
 residence.
- These are the following city entities that have been assisting with the property: Law Corp Attorney- Martha Cardenas Delgadillo City of Oakland Code Enforcement Inspector- Travis Ha Neighbor Service Coordinators- Araina Richards, Claudia De La Cruz-Perez
- o 2. Multiple vehicles have been parked IFO the property they have been towed.
- O There was an arrest made in the front yard of the residence on 17 May 22 refer to report **22-022314** after a shooting occurred on 17 May 22.

The results of Deputy Chief Angelica Mendoza's and Capt. Bassett's Command Directives demonstrated significant results with the address being red-tagged and the blight is being removed. The CROs are awaiting for the law corps to author a search warrant so that officers can remove the occupants from the address. This will significantly increase the quality of life issues in the 2300 block of Humboldt Ave.

Area 5 Crime trends, priorities, and areas of focus during 2022 Q1:

Area 5 was re-organized covering beats 26 through 30 on 22 Jan 2022. Previously, Area 5 was comprised of beats 29 to 35. After a comprehensive review of the combined data, it was apparent shootings and carjackings had shown distinct increases. Recognizing the increases, A/Capt. Febel implemented the following strategies:

- In review of the data and information from the community, it was determined a significant portion of the violence was being driven by group or gang conflicts. Firearm related assaults were up over 16%.
- O Carjackings were being largely driven by juvenile offenders who continuously re-offended after even after arrest. Carjackings increased over 50%. Carjackings in Area 5 were largely suspected to be a result of younger group known as the Fein Team.
- ShotSpotter activity and victims of shootings were concentrated in open air drug market areas and in areas where groups or gangs were known to congregate in Area 5. Beat 27X which contains known loitering locations for Case Gang, Sem City, UNT 60's Nortenos gangs, and Fein Team, drove a significant portion of the firearm related assaults.
- As a result of the data, weekly intelligence reports were provided to Patrol watch commanders, all Area 5 sergeants, and all Area 5 officers to more rapidly and efficiently direct available resources to those areas most effected by violent crime.
- We ensured thorough preliminary investigations including comprehensive canvasses were being completed and followed up on by our Criminal Investigations Division.
- Violence Suppression operations were implemented and strategically focused on those driving the violence.
- o Area 5 implemented A/Capt. Febel's *Micro Intel Strategy*.

- The VCOC and DVP stakeholders directed resources to those locations and those individuals who were most likely driving the violence.
- o Prioritized Ceasefire strategies and referrals/requests to and for assistance, outreach, and prevention.

The results of Deputy Chief Angelica Mendoza's and A/Capt. Febel's Command Directives demonstrated significant results. Area 5 had the largest reduction in ShotSpotter activations in the City with a 20% decrease. Assaults with a firearm were reduced by 44%. Shootings into a residence were reduced by 62%. Overall robberies were reduced by 13% and carjackings were reduced by 9%. The reduction of carjackings by 9% was significant because the city experienced a 20% overall *increase* in Q1, where Area 5 had reduced them.

A community survey was conducted in east Oakland in 2021. The community overwhelming identified two quality of life categories as their top priorities. Abandoned automobiles and traffic safety. CRO East's staffing through attrition during 2021 was reduced from 14 officers to just 5 for Q1 of 2022. As a result, their operational strategy was geared towards addressing the top complaints of the Area (Areas 4,5, & 6) as a whole to ensure that all communities were getting equitable community service based on their logistical bandwidth.

Area 6 Crime trends, priorities, and areas of focus during 2022 Q1

Area 6 was re-aligned based on a six (6) District model beginning on 22 Jan 22. Area 6 now encompass beats 31X/Y/Z, 32X/Y, 33X, 34X, and 35X/Y. After a comprehensive review of the combined data, it was apparent shootings had shown distinct increases. Recognizing the increase, A/Capt. Johnson implemented the following strategies:

- In review of the data, beats 32X/Y and 34X had the highest count of Shootings, Shotspotter activations, and Part 1 Crimes.
- Beats 32X/Y and 34X had three prominent feuding gangs to include the Boarder Brothers, Case Gang, and ENT.
- As a result of the data, ShotSpotter units have been assigned to work on an overtime basis seven (7) days a week throughout the Area 6. This ShotSpotter unit will be responsible for rapidly responding to all ShotSpotter activations throughout Area 6.
- Patrol units will be assigned to conduct intelligence lead targeted enforcement. Patrol units will be deployed to these area (s) to have a deterrent presence in addition to the focused enforcement. The direction is very clear that random stops are not a tool to be used during this operation.
- The VCOC and DVP stakeholders directed resources to those locations and those individuals who were most likely driving the violence.
- Prioritized Ceasefire strategies and referrals/requests to and for assistance, outreach, and prevention.

The result of Deputy Chief Mendoza's and A/Capt. Johnson's Command Directives demonstrated significant results. Area 6 had the largest reduction in Part 1 Crimes throughout East Oakland with an overall reduction of 28%. Homicides were reduced by 70%. Aggravated Assaults with a firearm reduced by 32%. Robberies reduced by 26% and carjacking's reduced by 21%.

CRO East Focus

Weekly Tow Sweeps:

• East Oakland community members have expressed their top priority is blight in their community. With particular attention to abandoned automobiles. CRO east, and our partners at Abandoned Auto, will be conducting numerous tow sweeps in the areas identified by local citizens as needing the most service.

Traffic Operations:

• In review of Area 4's High Impact Network (HIN) intersections, it was noted that of the ten (10) locations, with six (6) or more injury collisions, Area 4 had nine (9) of them. Area 5 had six (6) This was particularly alarming for our community members. Working with our community members we will identify locations for additional traffic enforcement operations.

- In Beat 6X Hoover Durant, the NSC will host another City of Oakland General Plan with SAHA and the Planning Department to encourage Cantonese, Spanish and Russian speaking residents to attend.
- In Beat 8X Ujima Friends NC NSC did outreach around Neighborhood Watch.
- In beat 14X Adams Point NC NSC is working with the steering committee to gear up for National Night Out and the City Challenge.
- In Beat 22X the NC enjoyed a community engagement event with good food from the Nitty Gritty and Dimond Slice Pizza. Both are Oakland eateries.
- In Beat 26Y, Oakland Housing Authority (OHA) has joined with the NEST and Neighborhood Services in attending their resident events.
- In Beat 31X & 31YZ the merchants and the City of Refuge Church held an Owners &
 Operators meeting to discuss various issues plaguing the Hegenberger Loop, Enterprise Way

- & 98th Avenue businesses. There were City & County agencies at the meeting to discuss the (3) priorities identified by the merchants.
- In Beats 20X, 21XY, 23X, 24X & 27Y the NSC is successfully partnering with non-profit and government agencies in Alameda County to build a strong rapport with other professionals/agencies as an on-going process.
- In Beat 31YZ, on May 14th a Community Health Fair was hosted by Beat 31YZ NC in partnership with the Sobrante Park Resident Advisory Council (RAC). There were approximately 300 participants, with 40 partners present who had tables to pass out information. Participants were excited about the amount of resource information and handouts that were available. Partners that joined the event that day were:

Beats With Challenging Projects

- In Beats 2X/5X Acorn & Oak and 6X Hoover-Durant, they continue to have a massive influx of encampments that are overflowing into residential communities.
- In Beats 20X, 21XY, 23X, 24X & 27Y, the NSC will continue to conduct outreach in the black and brown neighborhoods to increase NC membership. The NSC will encourage the most vulnerable residents in our community to voice their concerns.
- In Beats 29, 31X, & 32Y the reckless driving continues to be a huge issue for the residents. DOT is working with the NC's to find creative traffic calming devices.
- In Beat 26XY, the NC ordered door hangers and are looking for volunteers to help distribute them through the neighborhoods. The NSC for the beat will be assisting those that want to volunteer.
