## 1. Purpose

The purpose of this addendum is to provide clarification to the Crowd Control After-Action Report May 29 to June 4<sup>th</sup>. The following items in bold are the changes that have been made in the amended report.

- At 2148 hours, two federal security officers were shot blocks away from Oakland City Hall and the PAB. One of the security officers died and the other was critically wounded. **The federal security officers were targeted and attacked by two men associated with the Boogaloo movement, a far-right anti-government extremist group. The men were not part of any crowd that assembled that night, however this was not known at that time. It was later learned through a federal investigation the men used the demonstrations and riotous behavior as cover to plan and carry out their attack.** (p.17)
- Two federal security officers were **targeted and shot by two men who were a part of the far-right extremist Boogaloo movement** while **the officers were on-duty** guarding the Ronald V. Dellums Federal Building parking garage at the corner 12th Street and Jefferson Street. One of the officers did not survive the shooting. Even though this murder occurred little more than a block away from active protests and riotous behavior, OPD personnel rendered aid and gathered evidence the best they could until it was no longer safe to do so. Both security officers were **swiftly** evacuated from the area. Personnel collected evidence and evacuated the area only when the danger posed was greater than the need to maintain the crime scene. At certain chaotic points, the Incident Commander took control over the radio and helped maintain calm and focus. (p.22)
- During the event OPD was unaware of the Boogaloo group and believed **assailants** could be targeting officers and government facilities. Federal Investigators later determined that the Federal Protective officers were shot by a pair of anti-government extremist **members of the Boogaloo movement who were separate from the crowds that assembled that night and** who targeted the **officers** specifically using the demonstrations as cover for their crimes. One of the Federal protective officers were killed and the other was wounded. (p.23)
- Use of Force reporting for mass events should be reworked. The Department should consider having a Use of Force Report Writer for each company or platoon. This reporting shift should also extend to how we capture the event, including video teams. **Training and planning with video teams needs to occur to ensure the entirety of the event is captured.**

- On Tuesday, 2 Jun 20, the Department **elected to wait out the people protesting and not enforce the curfew by focusing on acts of criminal behavior and violence. This tactic should be considered in future circumstances.** (p.64)
- **Situational Reports- Situational Reports are comprised of information that is reported to the Emergency Operation Center from various field units, community input, news reports, and other open sources. These reports are meant to provide awareness, however have not been verified.** (p.66)
