RESOLUTION NO. 12-7-22

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE COMMUNITY POLICING ADVISORY BOARD AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See* <https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-Coronavirus-SOE-Proclamation.pdf>

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See* <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html>;

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See* <https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html>;

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See* <https://www.cdc.gov/aging/covid19/covid19-older-adults.html>;

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19

symptoms stay home. See <https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html>;

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. See <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html>;

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. See <https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html>;

WHEREAS, the City's public-meeting facilities are indoor facilities that do not designed to ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; now therefore be it:

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to in-person meetings, thereby putting them in close and prolonged contact with additional people outside of their households; now therefore be it:

RESOLVED: that the Community Policing Advisory Board finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this Resolution; and be it

FURTHER RESOLVED: that, based on these determinations and consistent with federal, state and local health guidance, the Community Policing Advisory Board determines that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

FURTHER RESOLVED: that the Community Policing Advisory Board firmly believes that the community's health and safety seriously and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Community Policing Advisory Board will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Community Policing Advisory Board finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever is occurs first.

Subject: Monthly report from Neighborhood Services Division (NSD)

Successful Community Partnership

- The West Oakland Neighborhood Enhancement Service Team (NEST) hosted a Kick-off event for a future mixed-use property with Panoramic Development Company at the Kirkham & 5th Street area. Councilmember Fife greeted and discussed the proposed developers, ELF Team, Beautification Council, along with several other City Departments were in attendance. The overall goal is to clean up, repurpose and revitalize the area for the community.
- West Oakland Neighborhood Council chairs and Councilmember Fife organized a public safety Town Hall meeting to address the overwhelming incidents and concerns that the beats in West Oakland have been experiencing.
- Adams Point 14X – The Community Family Resource Center will be scheduling a read along with OPD and the center's kids from 0-5 years old in a couple of months. A great way to build community partnerships.
- On Halloween, the NSC and the Juan Toscano Anderson Foundation (JTA Foundation) collaborated on a successful Trunk or Treat event. During this event residents were made aware of the Thanksgiving food baskets that are going to be distributed by the JTA Foundation for anyone in need.

- Ujima Friends 8X – The Neighborhood Council is working to help the merchants on 24th & Broadway create the Broadway Valdez Safety Plan. The safety plan is much needed to curtail the crime that is plaguing the community, businesses, and the First Friday activation.
- The NSC, CRO's, Fremont High School Principal, the Melrose 27X chair met with the Melrose 27X **YOUTH NC** over pizza and soft drinks to begin casual conversation. The goal was to break down barriers and stereotypes around the police.
- In beat 26Y, a school is hosting a safety day and creating an engagement opportunity for pre-school aged students to interact with Oakland Police Department staff.
- In partnership with Lodestar Community School, City of Oakland's Public Works, Waste Management, Sobrante Park Resident Action Council (RAC) joined together in the Inaugural Bulk Waste Block Party. Over 6 tons of trash was collected from Sobrante Park residents and dropped off at 105th & Edes. A mobile volunteer trash pick-up service was provided for families who did not have the capacity to come to the dump site. The Neighborhood Services Division and District 7 City Council office also recognized the invaluable, tireless effort of community leaders from the Sobrante Park RAC and Beat 31YZ NC during a formal award ceremony. - In Sobrante Park the second annual Harvest Festival and Trick or Treat was held in partnership with Lodestar Community School, Sobrante Park Resident Action Council (RAC), Beat 31YZ NC and 12 plus community partners. Close to 1000 family members trick or treated, watched live performances, engaged in arts and crafts and had the chance to win various raffle prizes. (See attached flier)

Beats with challenging projects

- Fitzgerald Homeless Encampment is experiencing open drug dealing. The encampment is a danger to the community.
- Beat 19X's challenge is to deter illegal dumping. Since the weather has been cold they have paused their monthly clean-ups.
- In an ongoing effort, the Neighborhood Services Coordinator continues to conduct outreach in the most vulnerable neighborhoods. The NSC continues to work on establishing a Fruitvale Resource Center for the residents and merchants.
- In Beat 27X – the area of 45th and Bond continues to have an encampment issue that includes abandoned vehicles.
- In Beat 35X, the NC is partnering with their City Council office to address illegal dumping by planning a bulky drop off event at a local church.

Community Project (Complete or in Progress)

- Beat 7X – has an ongoing blight problem with the vacant Mattress Guy’s building. The City Attorney confirmed that the building is going to be demolished. (In progress)
- Beat 19X’s prostitution has been a constant problem. OPD and Public Works is planning a pilot project to address the prostitution. (In progress)
- The NSC goal is to have a resource center made available to the residents and merchants. In collaboration with other agencies and OPD, the NSC will be able to provide referrals/resources and a sense of safety to those individuals and families that reside on the beat. (In progress)
- In Beat 30Y, addressing issues related to re-encampment on the 6700 and 6800 block of Foothill Blvd. (In progress)
- In Beat 29 & 32Y abandoned vehicles continue to be a concern on the beats. Especially around the Evergreen Cemetery. The vehicles are reported to OAK311 and given to OPD when there are active tow sweeps. (In progress)
