The plazas are related to two projects that were approved under **Case File Numbers PLN15241 & PLN15336**, which required development of the two plazas as set forth in the Broadway Valdez District Specific Plan. Conditions of approval on both projects required that the plazas return to the Design Review Committee as the design and public art concept are more refined. - **3.** <u>1314 Franklin Street</u>; Design Review discussion for a proposed mixed use development containing approximately 16,000 square feet of ground level retail and 630 dwelling units encompassing the entire City block bounded by 14<sup>th</sup>, 13<sup>th</sup>, Franklin and Webster Streets. The proposal would include a seven story building base and a 40 story tower at the western end of the site. This item had previously appeared before the Design Review Committee on November 30, 2016 and was requested to return with further design refinements. Case Number PLN16295.
