However, this does not mean we as city councilmembers are taking a break. There is still plenty of work to do on homelessness and affordable housing, gun violence and robberies, pedestrian/transportation safety, and more in our neighborhoods. My office will continue to monitor our neighborhoods and work with you to solve any issues that come up.

Before leaving for the break, the city adopted a new budget with amendments from the city council. I have included an overview of the budget in this newsletter as well as the amendments of mine that went through to share with you. I encourage you all to keep sharing with us ways to improve our district and our city.

City Budget Update

On June 26th, after a two-month long process, the City Council adopted a two-year budget effective July 1st. Facing a nearly \$180 million dollar deficit each year, the Mayor and Council were forced to make tough decisions in difficult circumstances to balance city services and available funding.

A few highlights of the adopted budget include:

- 1. A SIGNIFICANT INVESTMENT IN AFFORDABLE HOUSING: The Proposed Budget allocates over \$200 million over the next two years for the creation and acquisition of affordable housing -- some of which will serve our homeless population.
- 2. FUNDING OF SIX POLICE ACADEMIES along along with funds for violence prevention.

- 3. EXPANSION OF EARLY CHILDHOOD EDUCATION: The Proposed Budget uses federal, state and local funds to allow for the expansion of hours and services at Oakland's Head Start and Early Head Start program.
- 4. INFRASTRUCTURE IMPROVEMENTS: The Proposed Budget includes more than \$106 million in funds to build, repair and upgrade parks, recreation facilities, libraries, storm drains and non-road infrastructure. And it includes \$87 million to continue street repaying as part of Oakland's 5-year paying plan.

The Council amended the budget to preserve fire service, phase in 24/7 crisis response, add civilian investigators to the police department, and add community ambassadors to business districts.

Meeting with constituents, community organizations and city staff helped inform our budget conversations. I have received a lot of feedback from residents of District 1 regarding requests for this budget. I was able to fight for a number of key services for Oakland. As public safety is a top priority, I wanted to make sure we provided funding for the Police Department and for the Department of Violence Prevention. I also made it clear that it is essential to prioritize 911 dispatchers to improve our 911 wait time. Additionally, I worked to ensure we did not lose essential senior center programs.

The budget provides necessary resources for violence prevention and effective crime prevention/intervention efforts. I am thankful my colleagues agreed to three of my critical additions to the proposed budget:

- 1.Restoring critical senior center services via unfreezing a key supervisor position.
- 2.Restoring an additional \$750,000 dollars of grant funding to the Department of Violence Prevention for grantees working to curb violence on our streets.
- 3. Prioritizing hiring and retention of 9-1-1 dispatchers to improve response time.

We are very appreciative to our City Staff, and especially to our Finance Department, who worked tirelessly through nights and weekends to ensure that we have the most timely and accurate information. Their work helped us create and pass a thoughtful and balanced budget.

We still have many challenges in front of us. We will continue to serve our good City with integrity and concern for all as we navigate the challenges ahead.

I want to express our thanks for Captain Jeff Thomason who served as our acting area police captain for over a year. We had the pleasure of working with Captain Thomason on a wide range of issues, and I want to commend him for the job he did in our area.

Moving forward, Captain Lisa Ausmus will be the new area captain for the overwhelming majority of our council district. With the new captain, I and our District 1 team will continue to meet with her monthly to discuss crime trends and the pressing issues of our district. We look forward to working with her and her team on priorities such reducing robberies and assaults in our neighborhoods and along our business corridors.

Catalytic Converter Thefts

Our office is aware of the rise in catalytic converter thefts across the city and the state. Last year, the California State Legislature passed 2 bills to help address this issue. They were AB 1740 (Muratsuchi) and SB 1087 (Gonzalez).

These new laws are intended to disincentivize black market operations and dissuade further theft. Even before COVID-19 and rising inflation, most families could not afford to replace a stolen catalytic converter. A report from the National Insurance Crime Bureau found that owners pay \$1,000 to \$3,000 out of pocket to fix their vehicles. I urge the state of California as well as my partners at the local level to continue to look at additional ways to address catalytic converter theft.

AB 1740 (Muratsuchi): This law passed in 2022 went into effect on January 1st, 2023.

This new law requires catalytic converter recyclers to include in the information of the required written record the year, make, and model of the vehicle from which the catalytic converter was removed and a copy of the title of the vehicle from which the catalytic converter was removed.

The law prohibits these recyclers from entering into a transaction to purchase or receive a catalytic converter from a person that is not a commercial enterprise or a verifiable owner of the vehicle from which the catalytic converter was removed.

This new law also requires written agreements to include a log or other record of all catalytic converters received pursuant to the agreement that describes each catalytic converter with sufficient particularity so that each of those catalytic converters in the recycler's inventory can reasonably be matched to its description in the agreement.

SB 1087 (Gonzalez): This law passed in 2022 went into effect on January 1st, 2023.

This new law prohibits any person from purchasing a used catalytic converter from anybody other than certain specified sellers, including an automobile dismantler, an automotive repair

dealer, or an individual possessing acceptable documentation that they are the lawful owner of the catalytic converter. The law prohibits a recycler from purchasing a catalytic converter from anybody other than these specified sellers.

Mask Mandate Update

On July 1, the City Council's policy detailing mask-wearing requirements at City of Oakland locations will sunset, and there will no longer be any specific requirements regarding mask wearing in our City facilities. Additionally, please be aware that the City of Oakland's local state of emergency regarding COVID-19 sunsetted on June 18, after emergency declarations at the county, state, and federal levels were also ended.

Oakland Public Works' Facilities Services Division will continue to make disposable masks available upon request at the access points to City facilities staffed by contract security guards on the Civic Center Plaza. Departments managing other public facilities may also do so, at their discretion.

We still encourage those who are at risk and those who still wish to wear one to still do so. COVID still is in our communities, and the health of everyone in our community remains a priority of ours.


