Re: Notice of Industrial and Commercial Business Stormwater Inspection Fee

## Dear Oakland Business Owner/Manager:

Our records indicate you are the owner or operator of a business currently regulated by the City of Oakland's (City) Industrial and Commercial Business Stormwater Inspection Program (Business Stormwater Inspection Program). These inspections are required in the Oakland pursuant to the Municipal Regional Stormwater Permit (MRP), Order No. R2-2015-0049, issued by the San Francisco Bay Regional Water Quality Control Board (Clean Water Permit). **Beginning in August 2019, all businesses scheduled for a stormwater inspection will be subject to an inspection fee.** The Oakland City Council established the new Stormwater Inspection Program fee to provide cost recovery for regulatory compliance and water resource protection.<sup>1</sup>

The Clean Water Permit requires the City to implement a Business Stormwater Inspection Plan that:

- 1. Identifies businesses with the potential to cause or contribute to stormwater runoff pollution and describes how the businesses will be inspected either annually or once every three to five years depending on pollution risk level;
- 2. Categorizes the sites by pollutant threat and inspection frequency;
- 3. Directs City inspectors to require businesses to implement pollution control best management practices;
- 4. Implements effective follow-up to enforce the City's Creek Protection, Storm Water Management and Discharge Control Ordinance (Oakland Municipal Code (OMC) Chapter 13.16);
- 5. Must be updated annually to adjust inspection frequency based on inspection results; and,

### 6. Adds and removes sites as businesses open and close.

The table below describes the new stormwater business inspection fees. The fees depend on business type and are based on the estimated time it takes to conduct inspections. If a re-inspection is required to enforce OMC Chapter 13.16, a business inspection fee hourly rate will be applied. Invoices will be mailed to the property owner/operator within one month after the inspection or the re-inspection.
