OAKLAND CULTURAL AFFAIRS COMMISSION

RESOLUTION NO. 22-09-07

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE CULTURAL AFFAIRS COMMISSION AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See* https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-Coronavirus-SOE-Proclamation.pdf; and

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html; and*

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html*; and

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See* https://www.cdc.gov/aging/covid19/covid19-older-adults.html; and

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19

- symptoms stay home. *See* https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html; and
- **WHEREAS**, persons without symptoms may be able to spread the COVID-19 virus. *See* https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html; and
- **WHEREAS**, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See* https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html; and
- **WHEREAS**, the City's public-meeting facilities are indoor facilities that do not ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; and
- WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and
- **WHEREAS,** in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and
- WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and
- **WHEREAS**, on March 28, 2022 the Cultural Affairs Commission adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:
- **RESOLVED:** that the Cultural Affairs Commission finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this resolution; and be it
- **FURTHER RESOLVED:** that, based on these determinations and consistent with federal, state and local health guidance, the Cultural Affairs Commission renews its determination that conducting in-person meetings would pose imminent risks to the health of attendees; and be it
- **FURTHER RESOLVED:** that the Cultural Affairs Commission firmly believes that the community's health and safety and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Cultural Affairs Commission will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Cultural Affairs Commission finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever occurs first.

5. Artist Spotlight: Nadia Elbgal, 2022 Oakland Youth Poet Laureate

Commissioner Fowler introduced Nadia Elbgal, the 2022 Oakland Youth Poet Laureate. Nadia graduated from Berkeley High School this past June and is currently taking a gap year and serving Oakland as its 2022 Youth Poet Laureate. She is an active member in her community where she has mentored Yemeni students in OUSD elementary schools and is an activist for the Middle Eastern and Muslim communities.

Nadia is a songwriter who uses poetry daily and feels it is essential to writing her music. Poetry has always made her feel empowered and hopeful. It is a place where she can get her emotions out and is a form of therapy for her.

Nadia shared four original poems.

6. Cultural Affairs Division Manager's Update

Staffing Concerns

Chair Sanchez noted that Cultural Funding Program Coordinator position has still not been posted or filled, since Denise Pate's departure in October 2021.

Budget

Roberto Bedoya walked the Commission through the FY22-23 Granktmaking Scenarios Bedoya clarified that new funds allocated to Economic Workforce Development Department by the Mayor's office is directed to the Special Events Permitting Division with the intention of animating or revitalizing Frank Ogawa Plaza (\$350k) and the Lake (\$150k) with commerce and vendors. While Bedoya is an advisor, he is not sure what cultural elements will be infused in the result.

7. Public Comment

Comments were made by Assata Olugbala and Queen Ari of Jump Squad.

8. Action Item 3: Vice Chair Vote (Term August 1, 2022 – July 31, 2023)

Chair Sanchez thanked Vice Chair Lee for her service in the Vice Chair position.

Commissioner Kev Choice was the only candidate for the Vice Chair position. The Commissioners voted unanimously in favor of Commissioner Choice to serve as the next Vice Chair.

9. Cultural Affairs Commission Chair's Update

Chair Sanchez asked interested Commissioners to reach out to her regarding the staffing issues. She noted that an email with a chart explaining Commissioner terms will be distributed to CAC after the meeting so that Commissioners can start thinking about recruitment and timing. Sanchez proceed to highlight the priority areas that the ad hoc work would be required in the new fiscal year including: advocacy around the new mayor's budget, District 6 & 7 outreach and relationship building. She welcomed the CAC to provide other suggestions for priority areas. Commissioner Easton suggested a General Plan group and a focused advocacy group. Commissioner Choice suggested focused advocacy for Cultural Affairs, communications, and youth programming. Commissioner Whang noted that the CAC should deepen and strengthen the work the CAC has started, improve communications with the general public and Cultural Affairs staff.

10. Ad Hoc Team Update: District 6 & 7 Outreach

11. Ad Hoc Team Update: Community Cultural Development – Downtown Oakland Specific Plan

Commissioner Chan provided an update on the Downtown Oakland Specific Plan and the CAC's involvement in providing researched and written comment on Zoning Amendments that impact our cultural community. These amendments will be reviewed and approved by the Planning Commission and later the City Council by the end of 2022. The complete presentation slide deck is included at the end of the meeting minutes. Commissioner Chan noted that a letter with recommendations about the zoning amendments will be submitted to the Joanna Winter in the Planning Department after this meeting.

12. Ad Hoc Team Update: Oakland Mayoral Candidate Town Hall

Commissioner Fowler noted that an Ad Hoc Team includes himself, Commissioners Lee, Choice and Williams with assistance from Chair Sanchez and other Commissioners as requested. The plan is to host an arts Town Hall at Life is Living Festival in West Oakland on October 8 at the public library. Commissioner Lee expressed that the CAC found it valuable to highlight Oakland's arts and culture community prior to the election and use the Town Hall as a platform in the CAC's advocacy efforts in 2023. The Commissioners discussed and determined that all candidates for Mayor should be invited to participate.

13. Open Forum

No comment was made by the public.

14. Announcements Acknowledgements

The Commissioners spent some time sharing the various civic and cultural activities they have participated in or attended.

15. Closing


A motion to end the meeting was made by Commissioner Fowler, seconded by Commissioner Williams.

Downtown Oakland Specific Plan (DOSP) Timeline



Draft DOSP Zoning Amendments




A.1. Artisan Production Activities

(Treats small scale arts production/ creative commerce as commercial use, not industrial use.)

include, but are not limited to:

- a. Painting, drawing, photography, printmaking, and sculpture with the on-site sale of the art;
- b. Small-scale jewelry, metalworking and woodworking production and on-site sales;
- c. Picture framing, and digital printing and on-site sales;
- d. Fashion design with custom sewing, textiles, and clothes fabrication and on-site sales;
- e. Custom furniture making with hand tools and on-site sales; and
- f. Food production and on-site sales

During operating hours, **ground floor Artisan Production Commercial Activities shall be open to the public** to purchase and view items produced on site. On other floors, these activities shall either be open to the public during operating hours or available by appointment.



BAMBD Arts & Culture District

At **least 50% of the leasable floor area on the ground floor** of all newly constructed principal buildings shall be dedicated to Arts and Culture Activity Types.

B.1. BAMBD Arts and Culture Types of Activities.

Arts and Culture Types of Activities produce, display, sell, foster, support or disseminate artistic and cultural expression representative of the multi-ethnic character of the BAMBD. These types of activities also include operations that increase cultural awareness, serve and strengthen ethnic communities harmed by racial disparities, and educate Oakland residents about art and cultural practices and histories.

B.1.a. BAMBD **Administrative** Arts and Culture.

Administrative support activities for art- and culture-related non-profit educational organizations, institutions, and businesses. These activities also include organizations that have a mission to strengthen, serve, and educate underrepresented communities, particularly communities represented by the BAMBD and/or harmed by racial disparities, as defined by the Department of Race and Equity.

B.1.b. BAMBD **Active** Arts and Culture.

- i. Public and private performance spaces, including dance, theater and spoken-word venues;
- ii. Schools focusing on arts and/or cultural education;
- iii. Artisan Production Commercial Activities, as described in Section 17.58.040.
- iv. Art studios;
- v. Libraries;
- vi. Museums and galleries; and
- vii. Retail stores, bookstores, consumer services such as barber shops and salons, cafes, restaurants and bars that display rotating visual art, host performances and/or are oriented toward the specific cultures or ethnicities identified in the intent of this Combining Zone.

C. Determination of an Arts and Culture Type of Activity.

The determination of whether a proposal is Arts and Culture Type of Activity shall be made by the Planning Director, or their designee, in consultation with the Cultural Affairs Division. Such determination shall be subject to the right of appeal pursuant to the administrative appeal procedure in Chapter 17.132.
