On behalf of the Community Police Advisory Board (CPAB), we would like to thank you for your continued support of the city's Neighborhood Crime Prevention Councils (NCPC) as evidenced by your recent biennial general fund increase of \$24,000.

The 30.6% percent increase will go towards supporting NCPC related activities to elevate the communities knowledge of emerging issues and solutions to today's quality of life and violent crime concerns.

The CPAB is a diverse snapshot of Oakland's communities and is committed to a shared vision of fostering better community-law enforcement relationships. It's been four years since the CPAB held its annual Public Safety Summit.
