INFORMATION

As a continued best practice and in accordance with the City's Investment Policy, the Finance Department will publish a quarterly informational cash management report for the City Council. For the quarter ended September 30, 2020, the City's Investment Portfolio had a balance of \$1.21 billion and yielded 0.52 percent, while the Successor Agency's Investment Portfolio had a balance of \$18.50 million and yielded 0.07 percent.

As of September 30, 2020, the portfolios are in full compliance with the Investment Policy of the City for Fiscal Year (FY) 2020-21. The portfolios' credit quality remains high and well within Investment Policy parameters. Liquidity remains sufficient to meet projected cash flow needs for the next six months.

Provided in *Attachment A* are each portfolio's current market value and yield as of September 30, 2020, as well as comparisons to other market benchmarks. This report confirms that no leverage (use of debt to supplement investments) was utilized nor were derivatives (such as interest rate swaps, futures, or options) held during the reporting period.

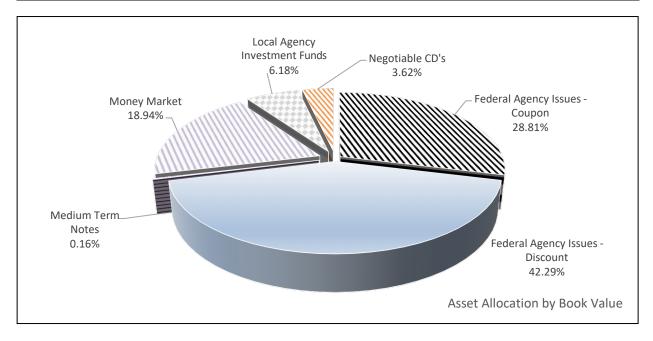

I. ECONOMIC REVIEW

MARKET OVERVIEW

COVID-19 virus pandemic has disrupted economic activity in many countries, including the United States. The longest expansion in the U.S history has come to an end in the first quarter of 2020 after almost 11 years, and U.S economy is in a recession. US Gross Domestic Product (GDP) has now deceased for two consecutive quarters in 2020, even with sharp rebound expected in third quarter of 2020, economic uncertainty remains. Most economists, including the Federal Reserve indicated that the economic recovery will be slow and gradual, not a quick "V" shaped recovery. The U.S economy is being threatened by resurgence in new virus cases as most business reopened and slowdown in hiring, and unknown availability of vaccine.

The U.S economy is expected to rebound sharply in the third quarter of 2020, as businesses reopen after COVID-19 pandemic lockdown. According to the U.S. Department of Commerce, Real Gross Domestic Product – the output of goods and services produced by labor – is expected to increase at an annual rate of 35.3 percent in the third quarter of 2020. The Real GDP had decreased 31.4 percent in the second quarter of 2020. The Real GDP rebounded in the third quarter as pandemic influenced lockdown eased, business partially reopened and consumers starting spending, especially with additional stimulus checks from government. Private domestic investments and government spending is also expected to contribute to rebound in the third quarter.

The U.S economy created fewer that expected jobs in September 2020, as hiring loses momentum with business facing financial difficulties during pandemic. According to the Bureau of Labor Statistics, Nonfarm payroll increased by 661,000 jobs in September 2020, after adding 1.49 million jobs in August 2020. The unemployment rate fell to 8.2% from 8.4% in August 2020. Economists were expecting adding 800,000 jobs. Leisure and hospitality sector led job gains with 318,000 jobs, as most business reopened, retail sector added 142,000 jobs, and health care and social assistance sector added 108,000 jobs. Government sector lost the most jobs, with 216,000 jobs lost, as schools and most government offices remain closed. Prior to the coronavirus impact, the unemployment rate was at 3.5%, the lowest in 50 years. The pandemic induced economic shutdown saw about 22 million layoffs since March 2020, with about 12 million jobs recovered up until September 2020.

U.S. consumer spending appeared to slow in August 2020, as fiscal support such as extra unemployment benefits were cut for millions of unemployed Americans. The Bureau of Economic Analysis reported that consumer spending, which accounts for almost 70 percent of the economy, increased 1.0 % percent in August 2020 after increasing 1.5 percent in July 2020. The personal consumption expenditure (PCE) price index excluding food and energy increased 0.3% in August. PCE index has increased 1.6% in the since August 2019. The core PCE is the Federal Reserve's preferred inflation measure and has a 2 percent target.

U.S. consumer prices increased for the fourth straight month in September 2020, with cost of cars and trucks rising by the most since 1969. However, inflation is slowing as the economy gradually recovers from COVID-19 recession. The Labor Department reported that its Consumer Price Index increased 0.2% in September 2020. The CPI had increased 0.4 percent in August 2020. Core inflation, which excludes volatile food and energy costs increased 0.2% in September 2020. The Consumer Price Index has increased 1.4 percent over the past year, which is now close to the Federal Open Market Committee (FOMC) inflation threshold of 2 percent.

U.S. consumer confidence rose more than expected in September 2020, as consumers were more optimistic about the future expectations as lockout eases, amid global economic slowdowns and continued volatility in financial markets amid coronavirus pandemic. The Conference Board reported

that its index of consumer confidence increased to 101.8 in September 2020 after 86.3 reading in August 2020. This was the biggest one month increase in 17 years.

U.S. retail sales increased more than expected in September 2020, as businesses resumed operations after coronavirus lockdown since mid-March and consumers spent more on clothing and accessories, sporting goods, music and books. The Commerce Department reported that retail sales increased 1.9 percent in September 2020, after increasing 0.6 percent in August 2020. Economists were expecting an increase of 0.7 percent.

U.S. manufacturing activity decreased slightly in September 2020 as manufacturing sector rebounds from lockout and signaling manufacturing entering expected expansion cycle, and as factories reconfigured to bring back workers safely. The Institute for Supply Management (ISM) said its manufacturing index decreased to a reading of 55.4 in September 2020, from 56.0 in August 2020. Activity was up due to increase in new orders and productions, and indicated expansion in overall economy for the fifth month, after April 2020, as any number below 50% signals contraction in the economy.

U.S. producer prices increased more than expected in September as the demand of cost of goods such as gasoline and services, iron and steel scrap increased as pandemic lockdown eased. The Labor Department reported that its producer price index for final demand decreased by 0.4% in September 2020 after increasing 0.3 percent in August 2020. In the 12 months through September 2020, the PPI increased 0.4 percent.

U.S. import prices slightly increased in September 2020, posting the smallest gain in five months, with products outside petroleum products posting modest gains. According to U.S. Bureau of Labor Statistics, import prices increased 0.3 percent in September 2020, after import prices had increased 1.0% in August 2020. Economists had forecasted import prices to increase 0.3 percent. In the 12 months through September 2020, import prices fell 1.1%, suggested imported inflation to remain deflated after rebounding slightly in the past few months.

U.S. homebuilding increased in September 2020, as housing sector continues to show positive signs in economic recovery, amid low interest rates and migration to suburbs and low density areas. The Commerce Department reported that Housing Starts increased 1.9 percent to a seasonally adjusted annual rate of 1.41 million units in September 2020. August had an annual rate of 1.30 million units. The Commerce Department also reported that single family homebuilding, which accounts for the largest share of the housing market, increased 8.5 percent in September 2020.

Sales of new U.S. single family homes decreased in September 2020, after hot summer buying season appears to cool off, however housing is still strong and is leading economic recovery. The Commerce Department reported that new home sales decreased 3.5 percent to a seasonally adjusted annual rate of 959 million units in September 2020. Home sales had increased 3.0 % in August 2020. The housing market is showing positive signs of recovery, and is leading recovery efforts fueled by low interest rates, as sales of new homes are up 32.1% since last year.

The U.S. existing home sales surged higher than expected in September 2020 amid record low interest rates and low home inventories. The National Association of Realtors reported that its index of existing home sales increased 9.4 percent to a seasonally adjusted annual rate of 6.54 million homes. August sales pace was 5.98 million units. Existing home sales makes up about 90 percent of U.S. home sales, up 20.9 % since last year.

INTEREST RATES

During the third quarter, the Federal Open Market Committee ("FOMC"), met on July 29th and September 16th, and on both meetings FOMC kept the funds rate at 0.00-0.25%. The FOMC has stated that the effects of the COVID19 virus will weigh in on the economic activity in the near term

and pose risks to the economic outlook, and FOMC is posed to keep federal funds rate at zero in the near term. The FOMC has indicated the path of the economy will significantly depend of the path of the virus. The Federal Reserve is prepared to use its full range to tools to ensure that there is liquidity in the market, that is to support the flow of credit to households and businesses. FOMC is willing to accommodate policy, so inflation can moderately exceed 2 percent.

The FOMC has reflected that some financial conditions have improved in part of policy measures implicated by Federal Government and Federal Reserve, however U.S economic uncertainty remains, and will require additional fiscal stimulus for continued economy growth. The FOMC committee expects to maintain this target range until it is confident that the economy has weathered recent events and is on track for its maximum employment and price stability goals.

II. CITY OF OAKLAND

PORTFOLIO REVIEW

The City's Portfolio balances decreased from \$1.37 billion as of June 30, 2020 to \$1.21 billion as of September 30, 2020. This net balance decrease was mainly due to the following: receipt of \$25.84 million in property taxes, offset by debt service payments of approximately \$90.10 million, and vendor payments of approximately \$98.57 million. The remaining balance increase of approximately \$10.63 million, is due to receipt of other revenues, such as Sales Tax offset by operational expenses such as payroll.

PORTFOLIO COMPOSITION

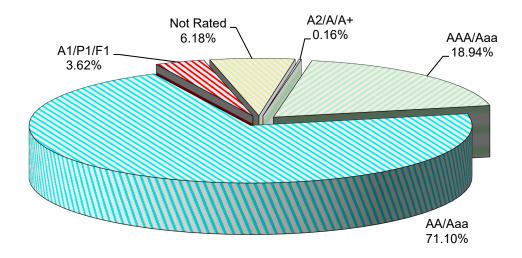
The Portfolio continues to comply with all provisions of the City's adopted Investment Policy for Fiscal Year 2020-21, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, Tobacco Divestiture, Fossil Fuels, and Guns/Ammunition.

The following discussion addresses the City's investment portfolio characteristics in terms of the Investment Policy's four objectives: safety, liquidity, diversity and return. Portfolio detail for each month of the current quarter is attached to this report.

<u>Preservation of Capital/Safety.</u> In the chart below, the City's holdings are depicted by credit rating category as of September 30, 2020. Approximately 71.10% of Operating Fund investments were rated in the AA/Aaa category while 18.94% in AAA/Aaa, 6.18% primary unrated holdings represent the Fund's investments in the Local Agency Investment Fund ("LAIF"), 3.62% in the A1/P1 category, and the remaining 0.16% in A2/A/A+. On August 6, 2011, the government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA. Moody's Investors' Service and Fitch Ratings continue to maintain AAA rating for government agencies.

The City's Investment Policy for FY 2020-2021 does not have a rating criteria level for government agencies.

<u>Liquidity.</u> Liquidity continues to be a primary objective when making investment decisions for the Operating Pool portfolio. With ongoing capital projects at the Port and within the City, and to ensure that sufficient liquidity is available to meet day-to-day expenditures, the City maintains a sufficient "cushion" in money market funds to meet unanticipated project expenditures.

Debt service payable from the City's Operating Pool for the Port and the City for the six months following September 30, 2020 is approximately \$162.18 million. Consequently, staff will continue to invest in short-term instruments and money markets as investment tools to maintain adequate short-term liquidity.

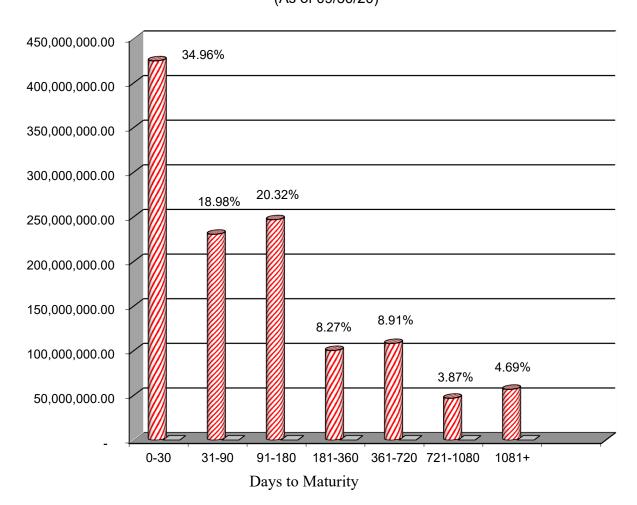
Investments maturing within 180 days include \$75.00 million in LAIF and \$230.00 million in money market funds, both of which are considered to have a one-day maturity due to the ability to withdraw funds daily.

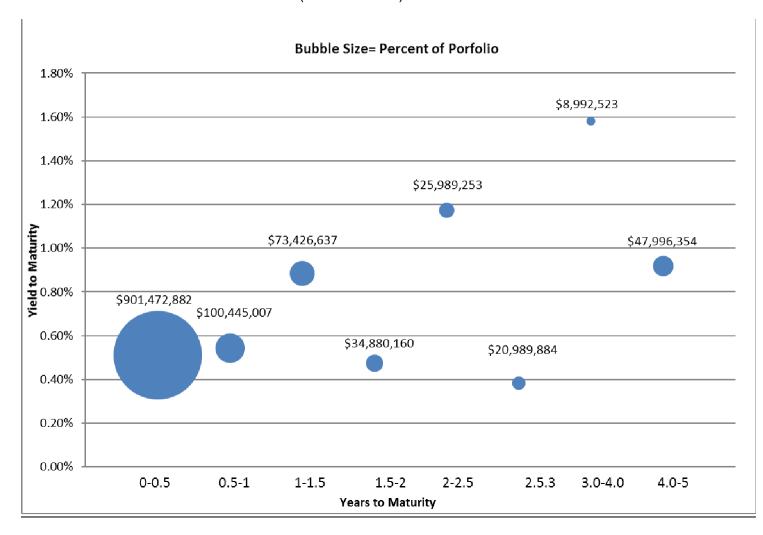
The following graph depicts the Operating Fund Portfolio by dollars invested and the percentage in each maturity range as of September 30, 2020.

City of Oakland Operating Fund Portfolio Maturity (As of 09/30/20)



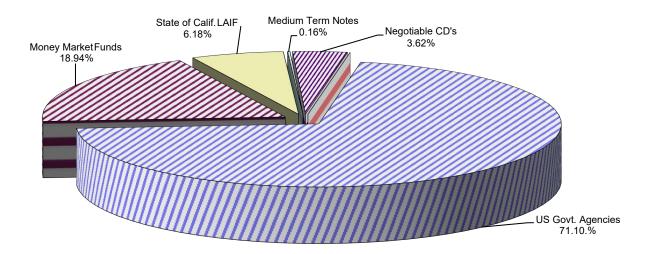

<u>Diversity.</u> To reduce the risks of investing, the portfolio is diversified among a variety of financial instruments, as depicted by the following chart. In addition to limiting the types of investments permissible in any one category as outlined in the Investment Policy, no more than 5% of the total cash portfolio may be invested in any one issue. This single-issue provision does not apply to money market funds or to LAIF, as they each are backed by a large portfolio of highly diversified assets.

<u>Derivatives.</u> The Operating Fund Portfolio contained no derivative instruments (interest rate swaps, futures, or options) during this reporting period.

<u>Yield.</u> Total interest earned for the quarter ended September 30, 2020 was approximately \$1,992,310. The effective rate of return on total assets in the Operating Fund Portfolio for month-end September 30, 2020 was 0.52% as compared to 0.96% for June 30, 2020. It continues to be the City's practice to hold investments to maturity rather than to sell at a loss and adjust to the market's yield curve. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and return in that respective order.

Benchmark Comparison:

The effective rate of return on total assets in the Operating Fund Portfolio for the month ending September 30, 2020 was 0.52 percent. The City's Operating Fund Portfolio had out-performed the 1 year government agency which yielded a rate of 0.05 percent. The City's Operating Fund Portfolio slightly underperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 0.69 percent.

The Alameda County Pool had a preliminary accrual basis rate of return for September 2020 of 1.44 percent. The Alameda County Pool had a Portfolio of \$6.48 billion with 647 days to maturity, meanwhile the City's Operating Fund had an accrual rate of return of 0.51 percent for September 2020. The City had a portfolio of \$1.21 billion with 217 days to maturity.

As of September 30, 2020, the City's Portfolio Fund's average days-to-maturity (ADM) was 217 days versus LAIF's average days-to-maturity (ADM) was 169 days.

The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The City does not actively sell securities in the portfolio to take advantage of cyclical swings in the market, which could result in the loss of principal. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and yield in that respective order.

<u>Valuation and Leverage</u>. Based on information received from Interactive Data Corporation, the market value of the Operating Fund was \$1.22 billion, which was above book value by \$2,567,965. There was no leverage in the portfolio during the reported period, and liquidity was maintained at sufficient levels.

The City's investment strategy, per the Investment Policy, is generally to hold securities to maturity. The net unrealized gains noted above are "paper gains" where there is an inverse relationship between the changes in market interest rates to the value of fixed income investment securities.

III. CITY OF OAKLAND SUCCESSOR PORTFOLIO

PORTFOLIO REVIEW

The Successor Agency's portfolio decreased from a balance of \$52.42 million as of June 30, 2020 to a balance of \$18.50 million as of September 30, 2020. The portfolio slightly decease due debt service payments of approximately \$35.25 million, and other vendor payments.

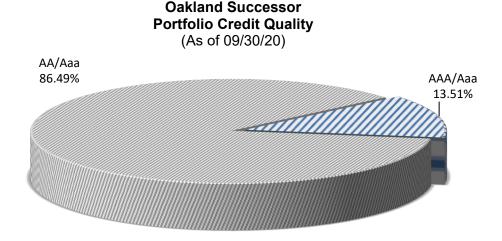
PORTFOLIO COMPOSITION

The Portfolio continues to comply with all provisions of the City's Investment Policy for Fiscal Year 2020-2021, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, and Tobacco Divestiture. In addition, the City will consider investing, when possible, in companies that promote the use and production of renewable energy resources and any other type of socially responsible investments.

The following discussion addresses the Successor investment portfolio characteristics in terms of the Investment Policy's four objectives of safety, liquidity, diversity and return. Portfolio detail for each of the months in the current quarter is attached to this report.

<u>Preservation of Capital/Safety.</u> The Successor's holdings by credit rating category are depicted in the chart below. Approximately 13.51% of Operating Fund investments were rated in the AAA/Aaa, while 86.49% were rated AA/Aaa. On August 6, 2011, the government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA. Moody's Investors' Service and Fitch Ratings continue to maintain AAA for government agencies.

The City's Investment Policy for FY 2020-2021 does not have a rating criteria level for government agencies.



<u>Liquidity</u>. Liquidity within the Successor's Portfolio remains sufficient to meet only debt service needs of the Successor for the next six months and beyond. The debt service payment for the next six months for the Successor is approximately \$6.35 million. The estimated six-month cash flow for Successor Portfolio is summarized below:

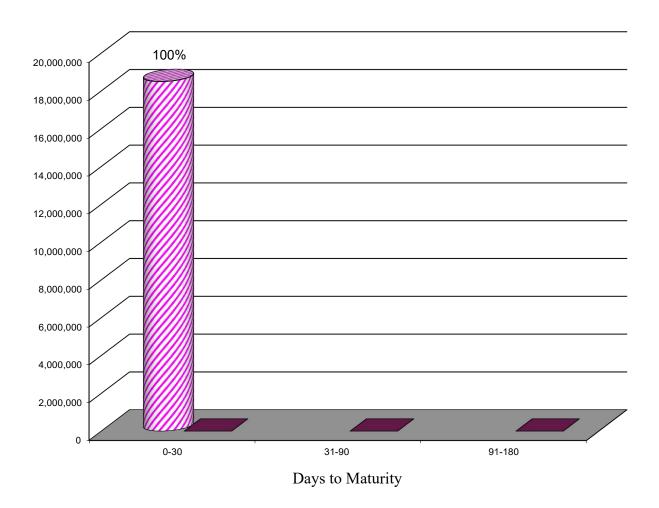

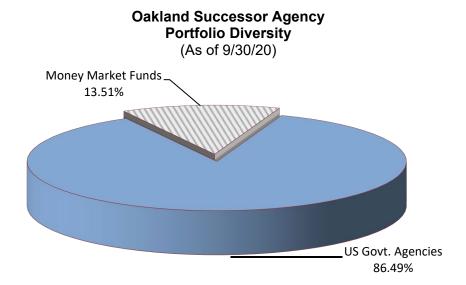

<u>Diversity.</u> To reduce the risks of investing, the portfolio is diversified among a variety of instruments, as depicted by the following chart. In addition to limiting the types of investment in any one category, as outlined in the Investment Policy, no more than 5 percent of the total cash portfolio may be invested in any one issue.



<u>Derivatives.</u> The Successor Portfolio contained no derivative instruments during this reporting period.

<u>Yield.</u> Total interest earned for the quarter ended Sept 30, 2020, was approximately \$17,987. The effective rate of return on total assets in the Successor's Portfolio was 0.07 percent for month ending Sept 30, 2020. The Successor's Portfolio outperformed the 1-year government agency which yielded a rate of 0.05 percent as of Sept 30, 2020. The Successor's Portfolio underperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 0.66 percent. The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The Successor Portfolio has extremely shorter duration due to liquidity concerns/needs, thus was able to only generate short term returns in comparison to LAIF and 1-year government agency.

As of Sept 30, 2020, Successor's Portfolio Fund's average days-to-maturity (ADM) was 17 days versus LAIF's average days-to-maturity (ADM) was 169 days.

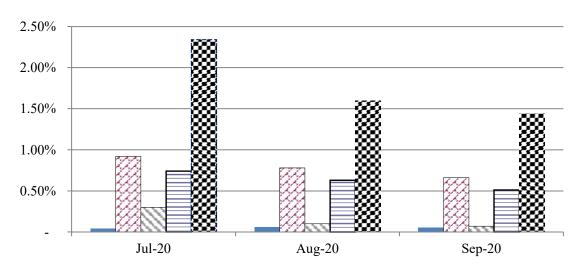
<u>Valuation and Leverage.</u> Based on information received from Interactive Data Corporation, the market value of the Successor portfolio for the quarter ended September 30, 2020 was \$18.50 million, which was above book value by \$586. There was no leverage in the portfolio during the reporting period and liquidity was maintained at sufficient levels.
