**MASKS REQUIRED FOR ALL WHEN INDOORS!**

With the Delta variant surging, the Alameda County Order directs that face coverings be worn over the mouth and nose in indoor public settings by all residents, with some exceptions, similar to statewide face covering requirements for unvaccinated residents. (whether you are fully vaccinated or not)



**Vaccination continues to protect against severe COVID-19 illness, but with the COVID-19 Delta variant now infecting a small percentage of vaccinated people as well as many unvaccinated people, eight Bay Area health officers have issued Health Orders requiring masks indoors in public places. **The Orders require all individuals, regardless of vaccination status, to wear face coverings when indoors in public settings, with limited exceptions.****

Vaccines remain the most powerful tool in the fight against COVID-19, including the Delta variant. Nonetheless, the Delta variant is infecting a small percentage of the vaccinated in the Bay Area — who still remain strongly protected against severe illness, hospitalization, and death. In those instances of infection in a vaccinated person, a face covering prevents further spread. Bay Area health officials urge all unvaccinated residents 12 and older to get vaccinated as soon as possible.

[These Health Orders](#) aim to reduce community transmission of COVID-19 and protect everyone. Health officials are very concerned by the substantial levels of community transmission now found across the Bay Area, especially among unvaccinated people. In part, this is due to the widespread COVID-19 Delta variant, which is substantially more transmissible than previous forms of the virus. Recent information from the Centers for Disease Control and Prevention also indicates that even fully vaccinated individuals can in some cases spread the Delta variant to others, and so indoor use of face coverings provides an important added layer of protection.

## Howard Terminal Waterfront Ballpark Project

The City of Oakland—including our Port—are in continuing negotiations with the Oakland A's regarding the terms and conditions of a proposed development project that includes a new Ballpark and substantial additional development on Port of Oakland property in West Oakland (<https://oakland.legistar.com/View.ashx?M=F&ID=9578130&GUID=91EC1721-8FCD-4854-8226-A336E3D865DE>).

On a 6-1-1 vote, the City Council approved a [non-binding term sheet](#) for this proposed project, with the understanding that there are remaining elements for negotiation that had not yet been agreed to. While I have some concerns with specifics of the term sheet, as well as the pending final EIR, plans for remediation of toxic contaminants, the seaport compatibility mitigations measures, and the pathway to achieve nearby affordable housing among other elements that are yet to be finalized, I felt it was important to move the conversation/negotiation forward on this project. There is still work to be done before the final package of documents come before the Council for consideration and approval.

## Emergency Operations Plan

Have you ever wondered how the City of Oakland is organized to respond to and recover from disasters? The city's **Emergency Operations Plan** (EOP) is the blueprint for response and initial recovery.

The City of Oakland is updating its EOP. The EOP is a flexible and adaptable document that guides the City through response and initial recovery to all types of hazards. The plan:

- Assigns emergency response actions to organizations and individuals for carrying out specific actions that is beyond their normal duties
- Establishes lines of authority and organizational relationships and shows how all actions will be coordinated
- Describes how people (including unaccompanied minors, individuals with disabilities, others with access and functional needs, and individuals with limited English proficiency) and property are protected

- Identifies personnel, equipment, facilities, supplies, and other resources available within the City or by agreement with other jurisdictions

Once trained, community members will know how to search for and rescue victims safely; and organize themselves and spontaneous

volunteers to be effective until professional first responders arrive.

Oakland is one of a few cities in California that has an independent, community-led Redistricting Commission responsible for the redistricting process. The Commission invites all Oaklanders to participate in its public hearing schedule, the next one is scheduled for [Sept. 8<sup>th</sup> \(via Zoom\)](#). **OAKLAND'S RIDGETOP REDWOODS**—*Amelia Sue Marshall*

Hike a varied terrain 1.5-mile loop through the redwood forest of Joaquin Miller Park and Roberts Regional Recreation Area. Learn how mid-1800s sea captains used the tallest trees to navigate around treacherous Blossom Rock. Meet the forester whose sleuthing resulted in a state landmark designation. Conclude with an optional bring-your-own lunch picnic.

**SHEPHERD CANYON AND TALES OF THE TUNNEL**—*Stuart Swiedler*

A walk on the Montclair Railroad Trail chronicles 20th century changes in Shepherd Canyon. We'll discuss the engineering marvel of Melin Cut, the Great Western Power Company, Wickham Haven's Victory Highway, the construction of Park Blvd., Banning's "Baffling Buildings", and the Sacramento Northern Railway tunnel to Contra Costa County. **LEIMERT'S LEGACY: Lower Oakmore's Secret Stairways and Storybook Homes**—*Laine Farley*

This "residential park" features charming storybook and period revival homes. Learn about popular styles, interesting residents, builders, and architects. Parts of the walk are moderately hilly; we'll traverse some secret stairs.

**MILLS COLLEGE CAMPUS**—*Karen Fiene, AIA*

Tour the verdant 135-acre campus. Highlights include the 1871 National Register Mills Hall, renovated after the Loma Prieta earthquake. See acclaimed architect Julia Morgan's 1904 El Campanil bell tower, 1906 Margaret Carnegie Library, and 1916 Alumnae Hall; and 1920s-40s buildings by Walter Ratcliff, Jr. Moderate walking, wheelchair accessible.

**SUNDAY, SEPTEMBER 19, 2021, 10 AM-1 PM**

**HISTORIC SITES IN JOAQUIN MILLER PARK**—*Dale Ridsen*

Poet/author Joaquin Miller spent his last decades on his 75-acre estate, The Hights, planting 75,000 trees, farming, entertaining, writing. Learn about his life with his wife Abigail, and daughter Juanita. Visit the Abbey, the Follies, and monuments that survive, more than 100 years later. The WPA Cascades and Woodminster Theatre were Juanita's idea, a tribute to the poets and writers of California. Hear about current restoration projects and issues at the park. A hilly walk.

**SUNDAY, SEPTEMBER 26, 2021, 10 AM-1 PM**

**BUTTERS CANYON HIKE**—*Dennis Evanosky*

Explore the headwaters of Peralta Creek, which the Peraltas, the East Bay's first European settlers, called home. This moderately difficult hike looks at the geology of the surrounding hills and watersheds that played a role in Oakland history. Get a close-up view of the efforts of the Butters Canyon Conservancy. A hilly walk.
