1.	A violator cited with an administrative citation may request to		
	perform community service in lieu of payment. A dumping violator		
	may not use community service to offset actual costs of the City's		
	addressing the illegal dumping incident. Community service must be performed in a program approved by the City Administrator.		
2.	A dumping violator who requests to perform community service		
	must make the request in writing with the City within 15 calendar		
	days after receiving the citation, excluding weekends and holidays.		
	Requests must include the address of the responsible person(s) for		
	the purpose of correspondence. A request to perform community service does not extend or toll the time within which the illegal		
	dumper must appeal any charge or penalty.		
3.	If approved to perform community service, the City shall notify the		
	dumping violator by first class mail, identify the program(s) that must		
	be completed, and the date by the program(s) shall be completed.		
4.	Community service may include, but not be limited to, picking up		
	litter or waste matter. The amount of community service shall be in proportion to the amount of the administrative citation.

5.	The obligation to pay the administrative citation shall be suspended during the time provided for completion of the approved program as		
	set forth in the written notification.
