General Plan Feedback on Environmental Justice Element

We are seeking the public's input to fully understand the excessive pollution burden, health impacts, and needs of Oakland's Black, Indigenous, People of Color (BIPOC) and low-income communities. EV Charger Technical Assistance for Multifamily Buildings in West Oakland

The Bay Area Air Quality Management District (Air District) and Alameda County public agency Stopwaste are partnering with local electrical contractor Energy Conservation Options (ECO) to provide no-cost electric vehicle (EV) charging station assessments for apartment buildings (5 units and above) in West Oakland and Richmond. This effort aligns with both the Air District's efforts to reduce air pollution in Environmental Justice communities and the <u>City of Oakland's Zero</u> <u>Emission Vehicle Action Plan</u>. The free assessment will involve an onsite technical assessment and follow up report detailing project scope, cost, and incentives to install EV charging stations. A subset of assessed buildings will receive full technical assistance, which includes help applying for incentive programs and support to secure permits and installation contracts. EBCE EV Charging Infrastructure Rebates

East Bay Community Energy, Alameda County's public power provider, is pleased to announce a partnership with the California Energy Commission's Electric Vehicle Infrastructure Project (CALeVIP). Businesses, commercial properties, multifamily housing properties, and public agency facilities in Alameda County can apply for rebates up to \$80,000 on eligible electric vehicle charger equipment and installation costs.

Induction Cooktop Lending Program and Rebates!

East Bay Community Energy (EBCE) and PG&E provide you a chance to try induction cooking for free. Induction is the most energy-efficient cooking technology available today. The difference is in the technology. See for yourself.

- EBCE: <u>Apply today to reserve your Induction Lending Kit</u>, which includes a portable induction cooktop and compatible pan, operating instructions, recipes and a carrying bag. The loan period is 21 days. The induction Cooktop lending Program is available to all residential electricity customers residing in the East Bay--EBCE customers as well as non-customers who receive service from PG&E.
- PG&E: PG&E's new Induction Cooktop Loaner Program offers plug-in countertop induction units for two-weeks, at no cost, to all residents. To borrow and learn more about induction cooking, visit <u>pge.com/inductionloaner</u> where you can start the loan process. PG&E will provide shipping details and cover shipping costs.

EBCE is also offering **up to \$300** per eligible residential customer for an induction cooktop/range, when you replace an existing gas appliance. Rebates are available on a first-come, first-served basis for qualifying residents with homes built in 2016 or earlier, and the customer must not have received a rebate for the same equipment, or other rebates funded with PG&E ratepayer dollars within the past 8 years for building shell, HVAC, and water heating measures. Induction cooking offers healthier indoor environments by eliminating harmful emissions that result from burning natural gas. Learn more and apply <u>here</u> today!



Surveys on Building Electrification

The City of Oakland wants to hear from you on your thoughts and perceptions on building electrification and how we can better facilitate the transition to 100% clean electricity in all buildings. Complete this <u>5-minute survey</u> here, also available in Chinese and Spanish.

Also, UC Berkeley researchers are looking for diverse homeowners and renters living in Oakland to participate in a study on household electrification. Participate in an interview to share your experiences and ideas on your home's energy needs. **You'll receive \$50 for your time**. Participating in the study involves a **30-45-minute interview in-person**, **preferably in your home** (following local health guidelines for COVID-19) **or in a video call**. Researchers will talk about any concerns you have about the reliability and affordability of energy services, and ask about your views related to any changes you have made or plan to make (or not!) in your electricity and natural gas consumption (i.e purchasing back-up generators, changing from gas to electric heating or installing solar panels). Tips to Lower Your Utility Bills

From 5pm to 8pm, PG&E charges a higher electricity rate due to heightened demand for electricity on the grid. Follow these tips to lower your utility bills today!

- Turn off TVs, lights, and computers that are not in use
- Shift use of large appliances like dishwashers and laundry machines outside of the 5-8pm period
- Use a fan to keep cool. Increased air circulation helps to stay cool while relying less on air conditioning.



EBCE Resilient Home Program

Resilient Home is a program from Alameda County's public electricity provider East Bay Community Energy (EBCE). EBCE has done the upfront legwork to select an experienced partner, Sunrun, and pre-negotiated solar and battery backup system incentives for Oakland homeowners. To further lower customer costs, Sunrun will pay homeowners \$1,250 after installation for agreeing to share their stored energy with EBCE when demand on the power grid is high. This will help the grid operate more reliably, and cut carbon emissions and costs for all EBCE customers.

New Water Dispensers at City Libraries and Recreation Centers

Touchless water dispensers are coming to City of Oakland facilities! About two dozen water dispensers will be installed at Oakland libraries and recreation centers. Another dozen water dispensers are being installed at downtown City Center facilities. Water dispensers help reduce the overall use of single-use plastic water bottles. The City's Recycling Program staff allocated approximately \$150,000 in State grant funds to support the water-dispenser project. Stay tuned for updates on when the water dispensers are ready to go!

Community Development Block Grant Funds Food Hub Pilot in District 1

In June, City of Oakland recycling staff completed expenditure of the \$15,000 they were awarded by the Community Development Block Grant to create a food recovery hub pilot program in District 1. Recycling staff used the funds to purchase a refrigerator, oven, freezer, blast chiller, ice machine, and blender for Telegraph Community Ministries Center (Telegraph Ministries). Telegraph Ministries serves hot prepared meals as well as provides bags of groceries to food insecure residents in District 1. The pilot project met the intent of expanding food recovery capacity, a requirement of <u>SB 1383</u>. During the pilot period Telegraph Ministries was able to begin accepting donations from Whole Foods, La Farine, Safeway, and Rockridge Market Hall and they hope to continue expanding. They also created a partnership and offered to share kitchen space with the Self Help Hunger Program. Recycling staff provided a letter of support for Telegraph Ministries' application to StopWaste to fund the purchase of a truck that will be used for mobile food distribution, which Telegraph Ministries was awarded. Oakland Zoo is celebrating Plastic Free July by continuing our dedication to saying #NoToPlastic_and expanding our responsible purchasing and disposal of the plastic we use. We have been dedicated to this mindset for decades and officiated our stance against single-use plastic in 2022 with our No To Plastic Campaign (join us and <u>take the pledge).</u> The zoo's choices, including digitizing our 11,000 annual membership cards, prevent 1.5 tons of plastic waste from being created annually. This year we are empowering our staff to fight microplastic with a personal-sized fabric trash collection bag made by the women of the Kibale Community Action Project.
