#### 7. Age-Friendly Report: Communications Stakeholders Meeting

Chair Ricks opened the conversation with a brief overview of the meeting, before inviting Commissioner Garrett to further explain the recap of the Communication stakeholder meeting. Commissioner Garrett presented an update as well as what the groups 3 tangible next steps.

#### 8. Council Report

Scott Means provided a guideline of how to create the council report this year. Scott Means is looking for the 4 leads from each of the 4 domain stakeholder groups to provide updates with information for their section. The rest of the council report will be tied together by Scott Means, Commissioner Scott, and Chair Ricks. Commitment to have everyone's draft by April 22<sup>nd</sup>, 2022 was made.

9. HSD Aging & Adult Services/COVID-19 update, Scott Means, Aging & Adult Services Manager Scott Means opened this topic up with updated everyone on The Sugar Sweet and Beverage tax funds, that were released. Deadline for questions or concerns about SSB is April 15<sup>th</sup>, 2022. Scott provided his direct contact email <a href="mailto:Smeans@oaklandca.gov">Smeans@oaklandca.gov</a> if anyone wanted to discuss this with him. Chair Ricks re-opened the public form for anyone to speak and comment on this. Audience member Tanya Washington with United Seniors of Oakland gave a brief description of how the SSB fund helps their programs. Scott moved on to talk about an event for Madi Gras that was hosted at WOSC, was the biggest event since Covid and was successful. We are still limited on what we can do until masking indoors is removed. We can not have a fully open senior centers until there is no longer a vaccine or mask mandate. OAM (Older American Month) is scheduled next month May 4<sup>th</sup>, 2022 from 10am-12pm. We will have a brief MCOA meeting then introduce the OAM event.

**OPED:** Recruiting for senior services program analyst! Program is open and continues to serve the community. They are working to expedite the Taxi Script Service and launching the Go-Go Grandparent Platform that will provide Uber and Lift rides to seniors.

**MSSP:** Seniors are still opting into televisits, will continue to maintain cases with porch visits until they're comfortable letting people into their homes again.

**SCP/FGP:** The program is staffed by 1.5 FTEs. The program will continue to sufficiently serve the community while in the recruitment process.

**ASSETS:** We are hiring! If you know any older adults (strong need for bilingual) who would like to participate, send them our way. The senior aide TPT positions are minimum wage \$14.36/hour at 20hrs/week. There are also employment opportunities for Physical Fitness Instructors to apply as Recreation Specialists that will service the senior centers.

**SENIOR CENTERS:** Hosting tax services at the senior centers. Slowly bringing back rental services for agencies. Despite this, the Senior Centers continue to provide critical services that includes food distribution, membership registration and virtual/limited-indoor programming. Have upcoming events to RSVP for any upcoming events, presentations, or classes go to MyActiveCenter.com or call (510) 238-3284 M-F 9am-3pm. We have activities at all our centers. Introducing new Senior Center newsletter. A membership into an Oakland Senior Center is not a key into the city, but a membership into a community. Working on making our Senior Centers a

community benefit, improving seniors experience.

How will you measure success?	City Council will fund the pilot and partners will work more closely together to break silos and get information to and from all Oakland seniors.
What resources do you need to accomplish this?	City staff and staff from Unity Council and North Oakland Village will be looking into platforms. There may eventually be a need for tech help on transferring information between platforms. Ongoing training needs within the city and with partners.
What are any barriers you anticipate?	City may want to see positive results before funding. Dial back may be to just share the communication/database piece across partners rather than the full activity management/check in/fee management functionality that the senior centers need.
