District 1 Community Budget Forum - Saturday, May 18

Three-year Paving Plan Approved

On May 7, Oakland City Council approved the Oakland Department of Transportation's (OakDOT) Three-year Paving Plan, representing a three-fold increase in annual paving activity that will put the citizen-approved Measure KK infrastructure funds to very visible use all over the city. To see the streets included in the plan see this [map](#). Paving schedules have not yet been finalized. OakDOT will advise residents in advance of any paving work on their streets.

In addition to the approved streets, each District City Councilmember will have access to \$1 million in discretionary funding to pave streets that were not prioritized according to OakDOT's analysis. This will allow council district offices to identify important paving needs known only to the people who live in the area. As stated publicly, Dan will only consider using his discretionary paving funds on streets with a pavement condition index (PCI) of less than 30. PCI is a numerical rating from 0 to 100 that records the severity and quantity of each distress type (defects, deformations, cracks, ruts, longitudinal, transverse, centerline, meandering).

For context, please be aware that \$1 million is enough to pave approximately one mile. In District One, there are approximately 29 miles of <30 PCI streets that were not included in the Paving Plan. To see the PCI on your street, check the map at this [link](#).

Considering the above limitations, we continue to welcome suggestions from constituents about specific 'worst' streets they would like the Councilmember to consider for discretionary paving funding. Final decisions will be made in consultation with OakDOT by September 2019.

E-Scooter Permit Application Process Launched

Earlier this month Oakland Department of Transportation (OakDOT) launched its [application process](#) for motorized scooter sharing service permits in Oakland.

Motorized scooter sharing services have the potential to help achieve Citywide transportation goals by providing an easy and affordable way to get around Oakland. Evidence from other cities show that they can increase the "first-and-last mile" connection to transit and reduce single occupancy automobile trips. Additionally, motorized scooters emit no air pollution or greenhouse gases during operation. However, we do know that

motorized scooter sharing services can create new problems, including obstructing the pedestrian right-of-way.

The [permit process](#) enables the City to regulate dockless scooter companies ('operators') on issues including parking, safety, quality of equipment, public outreach, equity, data privacy, noise levels and more. There are also strict requirements for insurance and indemnification, ensuring that risks are borne by the Operators and not the City of Oakland.

Permit fees to be paid by Operators include both one-time and annual charges that aim to make the scooter share program cost recovering, along with a per-ride scooter parking fee to help fund the City's ongoing efforts to create safe travel infrastructure, including designated parking areas for E- scooters and expanded and affordable access to shared mobility services. Councilmember Kalb is also pushing for better enforcement of keeping scooters off our sidewalks.
