## ECAP IN ACTION

### City of Oakland Climate Leadership

As the UN Framework Convention on Climate Change meets in Glasgow this week for COP26, the City of Oakland joins 1,000+ cities in Cities Race to Zero, reaffirming their commitment to ambitious climate targets. [Cities Race to Zero](#) is a global campaign to rally leadership and support for healthy, resilient, zero carbon recovery that prevents future threats, creates decent jobs, and unlocks inclusive, sustainable growth. As a signatory, the City of Oakland has committed to:

- Pledge to reach (net)-zero in the 2040s or sooner in line with global efforts to limit warming to 1.5°Celsius.
- Explain what steps will be taken toward achieving net zero, especially in the short- to medium-term. Set an interim target to achieve in the next decade, which reflects a fair share of the 50% global reduction in CO2 by 2030 identified in the IPCC Special Report on Global Warming of 1.5°Celsius.
- Immediately proceed to planning at least one inclusive and equitable climate action that will help to place your city on a resilient pathway consistent with the 1.5°Celsius objective of the Paris Agreement and begin implementation no later than 2022.
- Report progress annually, beginning no later than 2022

The City of Oakland's [2030 Equitable Climate Action Plan](#), adopted on July 2020, directly addresses all these points and implementation work has already begun. City Council also adopted a carbon neutrality target of 2045. For a recap on the progress thus far, the [ECAP Anniversary Newsletter](#) contains many highlights, including the passage of an All-Electric New Construction Ordinance and creating the City's first Urban Forestry Master Plan.

The City of Oakland is also engaged in regional climate collaboration, such as with the [Pacific Coast Collaborative](#) (PCC). The Pacific Coast Collaborative includes British Columbia, Washington, Oregon, California, and the cities of Vancouver, Seattle, Portland, San Francisco, Oakland and Los Angeles. Together, these cities, states, and provinces are working together to build the low carbon economy of the future with ambitious goals for reducing greenhouse gas emissions at least 80 percent by 2050. To meet these commitments, the Pacific Coast Collaborative engages in regional action to transform power grids, transportation systems, buildings, and economies while increase resilience to a changing climate. ### EBCE Celebrates Opening of Scott Haggerty Wind Energy Center in Livermore

The new 57.5 megawatt wind farm is now generating power for Renewable 100 customers. East Bay Community Energy staff, Board members, colleagues, and the media gathered in Altamont Pass near Livermore for a ribbon-cutting ceremony for the new

Scott Haggerty Wind Energy Center. The 23-turbine, 57.5 megawatt facility will provide supply to EBCE's Renewable 100 customers, and has annual production sufficient to power about 47,000 homes. "In just a few years, we've made great strides in bringing more affordable renewable

energy and reinvesting our earnings back into the community to drive local green jobs, valuable programs, and more clean power projects." said EBCE CEO Nick Chaset. To watch a summary video about the project, click [here](#).

## EBCE Resilient Homes Program

[Resilient Home](#) is a program from Alameda County's public electricity provider East Bay Community Energy (EBCE). EBCE has done the upfront legwork to select an experienced partner, Sunrun, and pre-negotiated solar and battery backup system incentives for Oakland homeowners. To further lower customer costs, Sunrun will pay homeowners \$1,250 after installation for agreeing to share their stored energy with EBCE when demand on the power grid is high. This will help the grid operate more reliably, and cut carbon emissions and costs for all EBCE customers.

## EBCE Seeks Local Sponsors for Community Solar Project

## MATERIAL CONSUMPTION + WASTE

### Major Improvements to City's Bulky Collection

Oakland is proud to announce major improvements to the City's bulky item collection program. Effective November 15, 2021, Waste Management of Alameda County (WMAC) will provide expanded bulky service at no additional cost to residents. Oakland Single-Family and Multi-family residents can manage the disposal of their bulky items in the following manner:

- All Oakland residents may schedule an annual appointment with WMAC to drop off up to 4 cubic yards of their bulky items at no charge at WMAC's Davis Street Resource Recovery Complex and Transfer Station (located at 2615 Davis Street in San Leandro).
- Each Multi-Family tenant can schedule a curbside appointment once a year directly with WMAC to properly dispose of their bulky items.
- Single-Family households can schedule an appointment for bulky items collection at the curbside, increased from once per year to twice per year.

### EPA 2021 Environmental Education Grants

The U.S. Environmental Protection Agency (EPA) announced up to \$3 million in funding for locally-focused environmental education grants under the Environmental Education (EE) Local Grant Program. EPA will award grants in each of EPA's 10 Regions, for no less than \$50,000 and no more than \$100,000 each, for a total of 30-40 grants nationwide. The 2021 Requests for Application (RFA) notice is now posted on [www.grants.gov](http://www.grants.gov). Applications are due Dec. 6, 2021. Applicants should choose the RFA that is for the location of the project. EPA's Office of Environmental Education will also host two webinars on how to write a competitive application and to address commonly asked questions related to the 2021 EE Local Grants RFA.

Through this grant program, EPA intends to provide financial support for projects that design, demonstrate, and/or disseminate environmental education practices, methods, or techniques, as described in this notice, that will serve to increase environmental literacy and encourage behavior that will benefit the environment in the local communities, especially in underserved communities. EPA recognizes underserved communities as people or communities of color, Tribal and Indigenous populations that may be disproportionately impacted by environmental harms and risks, high-poverty areas, persistent poverty counties, and Title 1 schools for this grant program.
