OFCY PROGRAM SPOTLIGHT

Strategy: Violence Prevention Program: Youth Alive – Teens on Target (TNT) FY: 2022-2023

Excerpt from narrative response submitted

Program Overview

TNT will train 63 students at Oakland's Castlemont (23), Fremont (21) and Skyline (19) High Schools to be violence prevention peer educators and civic leaders, in 2-3 weekly after-school sessions and a 4-week summer program. TNT youth leaders will teach 100 violence prevention workshops to 270 students in OUSD classrooms, engage in 48 meetings and public events to advocate for peace, and earn stipends. TNT staff will provide 1,320 hours of 1:1 adult mentoring. New violence prevention knowledge and skills will transform young Oaklanders. At least 70% will mediate a conflict.

¹ CitySpan, Inc. is a cloud-based data management system for tracking social service programs, funding and outcomes.

Teens of Target will look to see if TNT youth leaders are safer, if they are forging healthy relationships, including with adults, which can indicate increased connection to school. Have they gained presentation and communication skills that will be useful beyond the program, confidence to speak up even among adults and civic leaders, and language to use when engaging peers and others in conversations about violence? TNT teaches mediation skills to youth leaders, who in turn pass along knowledge and skills to their middle school peers in TNT workshops.

Teens on Target will look for changed attitudes, about violence, about their city, and about themselves, measured in surveys administered prior to and after participation. These surveys cover the topics covered in TNT after-school sessions and which TNT peer educators teach to their fellow students.

Last year (FY 22-23) Teens on Target saw a 68% increase in youth leaders who believed that they "were good at teaching people" to prevent violence.

Among the items we measure are changes in:

- How frequently they got into fights
- How frequently they watched a fight at school or in their neighborhood, or on social media
- If they believe someone is safer with a gun than without one
- How frequently they have carried a gun themselves
- If they have chosen not to hang out with someone when they found out they carried a gun
- If they have talked to a friend about not carrying a gun

- If they believe that joining a gang or claiming a turf can negatively impact their life
 - If they have talked someone out of hanging out with people who are in a gang
 - If they know the difference between an abusive dating relationship and a healthy relationship, and where to go for help
 - If youth believe that there are things that young people can do to help reduce violence in their school and community
 - If they try to solve conflicts without fighting
 - If they have mediated a conflict that would have led to violence Last year,

Anecdotal Story - Participant Highlight / Achievement - Quarter 3 FY 2022-23

As the focus of her senior capstone project, one of our youth leaders has researched menstrual injustice, and how lack of access to free menstrual products creates challenges, especially for low-income and unsheltered people who menstruate. In addition to her research, she started her own fundraising campaign for menstrual products that she will distribute to unhoused people around East Oakland. This highlight is meaningful to us for a few reasons.

First, this student has come a long way in TNT. She is a 4-year participant of our program, and since starting she has found her voice and her power advocating and fighting for equity at her school and now in the community. Additionally, this youth leader was also at the inauguration of AG Rob Bonta, where she met Senator Nancy Skinner. Senator Skinner is coincidentally currently moving forward a state bill, Senate Bill 59, that would ensure Californians have access to free period products in all public buildings. Our Policy and Advocacy Director was able to connect this youth leader with Senator Nancy Skinner's staff so she could share more about her project and interview the staff about SB 59 for her project.

This was a full circle moment for this young person's leadership development to see how their advocacy connects to one of her state representative's priorities and meet with her office to make that connection.


