# OAKLAND PUBLIC ART ADVISORY COMMITTEE November 7, 2022 RESOLUTION NO. 1

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE PUBLIC ART ADVISORY COMMITTEE AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. See <a href="https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-Coronavirus-SOE-Proclamation.pdf">https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-Coronavirus-SOE-Proclamation.pdf</a>; and

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. See <a href="https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html">https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</a>; and

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. See <a href="https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html">https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html</a>; and

**WHEREAS**, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See* <a href="https://www.cdc.gov/aging/covid19/covid19-older-adults.html">https://www.cdc.gov/aging/covid19/covid19-older-adults.html</a>; and

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms stay home. See https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html; and

**WHEREAS**, persons without symptoms may be able to spread the COVID-19 virus. *See* https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html; and

**WHEREAS**, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See* <a href="https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html">https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html</a>; and

WHEREAS, the City's public-meeting facilities are indoor facilities that do not ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; and

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to in-person meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and

**WHEREAS**, on October 19, 2021 the Public Art Advisory Committee adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:

**RESOLVED:** that the Public Art Advisory Committee finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this resolution; and be it

**FURTHER RESOLVED:** that, based on these determinations and consistent with federal, state and local health guidance, the Public Art Advisory Committee renews its determination that conducting inperson meetings would pose imminent risks to the health of attendees; and be it

**FURTHER RESOLVED:** that the Public Art Advisory Committee firmly believes that the community's health and safety and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

**FURTHER RESOLVED:** that the Public Art Advisory Committee will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Public Art Advisory Committee finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever occurs first.

- 1. Welcome/ Roll Call / Meeting called to order at 5:40 p.m. Information on City of Oakland Boards and Commissions public comment procedures was presented.
- **2. Public Comment:** No comment was provided.
- 3. Action Item: Adopt a Resolution Determining that Conducting In-Person Meetings of the Public Art Advisory Committee Would Present Imminent Risks to Attendees' Health, and Electing to Continue Conducting Meetings Using Teleconferencing in Accordance with California Government Code Section 54953(e), a Provision of AB-361. Public Art Coordinator Kristen Zaremba stated that the Committee must adopt the resolution before conducting business for this and all future remote meetings until further notice. Committee members discussed the importance to balance community safety guidelines with City Hall access. Motion: J. Kesseler moved to approve the motion. E. Murphy seconded. M. Ramirez Aye. C. Roundtree-Baagee Aye. Motion passed unanimously.
- 4. Action Item: Review Staff Recommended Approval for Mural Design Proposal by Bay Area Mural Program (BAMP) for the Mosswood Park Field House. K. Zaremba thanked the Committee members for their ongoing contributions. Staff then presented the first of three projects initiated by community members and other departments for PAAC review as consent items with a staff recommendation for approval. Each of the three projects was presented by community members at the July 2022 PAAC meeting, but could not be voted on due to lack of quorum. The first of these projects was the mural proposal by BAMP, with the support of Oakland Parks Recreation and Youth Development (OPRYD), funded by Wells Fargo and secured by the community for landscaping improvements and the mural and presented as a

- gift to the City, for the Mosswood Park Fieldhouse. There is no funding plan for future maintenance. The artist was selected through direct selection. Zaremba shared images of the work in progress with robust community involvement. The artwork proposal has already been approved by the Parks and Recreation Advisory Committee (PRAC). The PAAC vote constitutes acknowledgment of the project and an endorsement of its intentions. Committee members discussed the process for these artworks coming to the City, commented on the value of bringing art to previously blighted park spaces, and acknowledged BAMP's expertise. Motion: C. Roundtree-Baaqee. moved to approve the mural design by Bay Area Mural Program (BAMP) for the Mosswood Park Field House. J. Kesseler seconded. E. Murphy Aye. M. Ramirez Aye. Motion passed unanimously.
- 5. Action Item: Review Staff Recommended Approval for Mural Design Proposal by Cultural Funding Neighborhood Voices Program Grantee ARTogether and Artist Pat (Sophat) Kong, for the Center for History and Community in Peralta Hacienda Historical Park, 2484 Coolidge Ave. This mural was partially funded through the Cultural Funding Program and staff have reviewed and authorized the team to move forward with design due to the previously determined project completion deadlines. Staff recommended approval and invited comments. Peralta Hacienda manages the property and is responsible for maintenance. The mural is located on the Southwest facing wall. PAAC members expressed support for the project and Peralta Hacienda. Motion: E. Murphy moved to approve the Mural Design Proposal by Cultural Funding Neighborhood Voices Program Grantee ARTogether and Artist Pat (Sophat) Kong, for the Center for History and Community in Peralta Hacienda Historical Park, 2484 Coolidge Ave. E. Murphy moved to approve. J. Kesseler seconded the motion. C. Roundtree-Baagee Aye; M. Ramirez Aye. Motion passed unanimously.
- 6. Action Item: Review Staff Recommended Approval for Mural Design Proposal by ARTogether and Artist Cece Carpio, for the San Antonio Park Tennis Court wall, located at 1701 East 19th Street. Zaremba presented the project proposal. The mural lead is ARTogether, the lead artist is Cece Carpio and the mural is funded by the California Arts Council and a small grant from Council District 2. The City requires approval by the PAAC as the work is proposed to be located on City property at San Antonio Park. The project included some Public Works staff repairs to the existing wall, which was requested by the City Council, outside the purview of the Cultural Affairs Division. The work will be maintained for a period of time but is not being vetted as a permanent artwork installation, and will be considered as part of the San Antonio Master Plan process. Committee members were excited to support the project and asked if there was any further conversation regarding lighting. Finally, committee members suggested sharing more details on how public feedback was collected and considered as part of the design process, noting that the public might also want to request low maintenance, low cost lighting to enhance visibility of the mural. Staff noted that as lighting would be considered a CIP project, advocacy may need to be voiced to City Council for future budgeting, and promised to convey the comments to the new Parks department staff person assigned to these capital projects. Motion: J. Kesseler moved to approve the Mural Design Proposal by ARTogether and Artist Cece Carpio, for the San Antonio Park Tennis Court wall, located at 1701 East 19th Street. E. Murphy seconded. C. Roundtree-Baagee Aye. M. Ramirez Aye. Motion passed unanimously.

- 7. Informational Item: Staff Updates on Current Projects and Program Activity
  - a. General Public Art Program Updates: 2022 Mid-Cycle Planning and Updates. Tabled.
  - b. Cultural Strategists in Government (CSIG) Program Update. Zaremba continues to work with Cultural Strategist Sorell Raino-Tsui and ABG group to launch a website the Equitable Art Advisory- and provide workshops to offer professional development for Oakland artists interested in the public art field, whether City commissioned murals, permanent public art on City property and public art for private development. The plan is for a website launch in the fall, and 2023 convenings which will be recorded. The project is funded by the Mellon Foundation, not the City, therefore PAAC approval is not required, but the City is a partner, and the work will be designed to support partnership with the City and the Public Art Program. Committee members and staff discussed the prior efforts to elevate and support artist professional development opportunities. Zaremba noted that CSIG will come back to the PAAC for a future presentation.
  - c. Public Art for Private Development Updates. Zaremba shared images of a recently completed project in dichroic glass by artist Ray King for the Holland Group at the Vespr development, 312 24<sup>th</sup> Street in the Broadway Valdez neighborhood. The installation started earlier in 2022, but was put on pause until the building construction was closer to completion. The second project, a mosaic by artist team Wowhaus, sits around the corner from the building entrance, above the development's dog park. The work includes signage at the street level for both projects. Another completed two-part project was presented, with works by Adia Millett and Hannah Perrine Mode, both Oakland based artists, for the Bishop O'Dowd High School expansion. The works are accessible to the general public, as long as visitors make arrangements in advance to visit the campus. The work was facilitated by ArtSource consulting to help the emerging public artists to successfully complete the projects. Zaremba finally noted that the program still strives to compile a database of completed projects for the general public to access in the future. Committee members expressed enthusiasm for all the completed projects.
  - d. NorCal PAAN Oakland Public Art Walking Tour: Zaremba reported that staff will be hosting the Northern CA Public Art administrators group, on Friday, September 16<sup>th</sup> and leading a tour of some completed projects in downtown Oakland. Committee members are invited to join the tour if available. This will be more of a 'shop talk' tour with other administrators. Staff continue to talk to Oakland Art Murmur about offering additional tours in the future, on weekends when others may be available.


The City of Oakland is seeking an artist to design, fabricate and install a new work of art for the Tyrone Carney Park located at the intersection of 105<sup>th</sup> Avenue and Acalanes Avenue in the Sobrante Park neighborhood of East Oakland. The park site is at a highly visible intersection, on a busy vehicular thoroughfare, in a mixed-use working-class neighborhood. An artist or team will be selected to develop an integrated public art project which enhances the redesigned park, preserves the community's memories of Tyrone Carney, the person, and contributes to the community's goals for a space that' conducive for contemplation. The artwork will ideally be integrated into the final design plans through collaboration with the project landscape architects, Dillingham Associates, Berkeley, California.

# Tyrone Carney Park Project Overview


Tyrone Carney Park, once a vibrant neighborhood park, was named in honor of Tyrone Edward Carney, the first African-American from the neighborhood to die in combat in Vietnam, in 1968, at the age of 20. Growing up in the Sobrante Park neighborhood, Mr. Carney was a Boy Scout and planned to become a minister. Neighbors recall that he signed up to go to war so others wouldn't have to.

The City fenced and shuttered the park in 2002 following increased violence and a brazen shooting death within the park. In 2008, the Oakland Redevelopment Agency awarded two Neighborhood Project Initiative grants to neighborhood residents totaling \$40,000 to redesign Tyrone Carney Park. The grants allowed the community to hire landscape architect Walter Hood to design the park and surrounding streetscape in conjunction with the City and the Alameda County public health department. Unfortunately, those plans were not implemented due to lack of funding. In 2019, community members successfully led the community engagement and grant application process for a California State Parks (Prop 68) grant to fund the design and renovation of the park. The project was awarded \$2.6M and is currently being managed by the City of Oakland's Public Works Department and being designed by Dillingham Associates.

An important design goal for park renovation is to create a restorative, contemplative space with a central memorial plaza. As the heart of the park, the memorial plaza will accommodate gatherings, quiet contemplation, and the location for a memorial to Mr. Carney. Other proposed park elements include new landscaping, play elements, and fitness equipment.

# **Artwork Goals**

There is no decision about what form the artwork (or works) will take but it must be designed in collaboration with community members and the City's landscape design consultant. The goals for the artwork are to preserve the community's memories of Tyrone Edward Carney and his values; to create a space for reflection and celebration; and to complement the park design as a whole. The selected artist must create meaningful visual elements that are appropriate to the project and responsive to the neighborhood values and history. Artwork must be accessible and visible to the general public.

# **Artwork Sites and Materials**

Preferred sites and materials for public art include:

- A memorial to Tyrone Edward Carney located within or easily viewed from the central plaza.
- If other works of art that are in addition to the memorial are proposed, they are not required to be located in the plaza.
- Materials must be durable and designed to withstand vandalism and/or graffiti. Materials to consider include metal, stone, recycled-content materials, or other permanent, durable materials.
- The work of art must be fabricated in durable, permanent media that are safe and easily maintained.
- Consideration must also be given to creating artwork that can be reproduced and replaced in the future if required.

# **Public Art Program Goals**

The goals of Oakland's Public Art Program projects include:

- (1) Enabling artists to create original artwork that enlivens, enriches and enhances the quality of Oakland's visual environment and public spaces.
- (2) Integrating the creative thinking of artists into the planning and development of capital projects.
- (3) Providing opportunities to advance the careers of artists and broaden the role of the artist in the community.
- (4) Providing a means for citizens and visitors to express, enjoy and experience cultural diversity through the visual arts.
- (5) Our program is guided by the principles uplifted in *Belonging in Oakland*, the City of Oakland's cultural development plan that aims to promote cultural equity, belonging, and well-being for all the communities of Oakland: <a href="https://www.oaklandca.gov/resources/cultural-plan">https://www.oaklandca.gov/resources/cultural-plan</a>

# **Eligibility**

This project is open to practicing, professional artists living or working in the Northern California Bay Area region, defined as the counties of Alameda, Contra Costa, Marin, Napa, San Francisco, Santa Clara, San Mateo, Solano and Sonoma. Artists working in all permanent visual media are welcome to apply.

# **Budget**

The public art budget for this project is \$70,000. This budget includes all artist/artist team design and collaboration fees; fabrication and transportation of work to site; collaboration with the design team for installation requirements; and artwork integration oversight as needed. Art installation costs will be covered by the larger project budget.

The selected artist(s) – or if a team, the lead artist – will be required to hold an Oakland Business Tax Certificate for the duration of the project, as well as to provide proof of insurance for commercial general liability, automobile, and worker's compensation (as applicable) in accordance with City standards.

# Review and Selection Process

# Phase One: Selection of Finalists

Submittals from artists will be pre-screened by Public Art Program staff for compliance with RFQ requirements. A **Selection Panel** (Panel) composed of three community members, City staff or member of the Public Art Advisory Committee, and the consulting landscape architect will meet to review artists' qualifications based on application materials. It is anticipated that the Panel will recommend three (3) finalists to be interviewed in Phase Two of the selection process.

Finalists (individuals and teams) will be selected based on the following criteria:

- Professional and artistic qualifications and standards of excellence in innovation, creativity and originality as demonstrated in materials submitted.
- Appropriateness of applicant's medium and style to the site.
- Previous experience as it relates to the project goals and setting.
- Experience with the public art review process and/or previous collaboration with various stakeholders.
- Demonstrated ability to successfully deliver the project on schedule, in a professional manner, and within the project budget.
- Artists currently living in or whose workplace is in Oakland will be given a nominal numerical preference.

<u>Phase Two: Finalist Submittal and Interviews -</u> The information below provides a general overview of the Phase Two process and is subject to change. City staff will provide supplemental information to the selected Finalists regarding selection criteria and submission process.

In preparation for the scheduled interviews, finalists will be required to meet as a group with Public Art Program staff, City project manager and the project designer to visit the site, review plans for the park renovation and request clarification pertaining to the interview questions.

Finalists will be required to submit a written proposal with renderings of their proposed approach and a working budget to the project. Further details describing the proposal requirements will be provided at a later date to the Finalists.

Finalists will present their approach and vision for this project to the Panel in a scheduled interview. The Panel will then recommend one artist or artist team to receive the commission. The Public Art Advisory Committee (PAAC) must approve the recommended artist(s)/team(s) before contracts can be executed.

Each finalist will receive an honorarium in the amount of \$1200.00 following their submittal of complete

proposal and participation in the interview.

# Public Art Project Assumptions

- The artwork may not interfere with public infrastructure, utilities, or right-of-way, and must meet City code and permit requirements and ADA requirements.
- The public art should reflect and complement the surrounding community.
- The artwork must be durable and resistant to vandalism.
- All proposed locations and concepts for artworks are subject to approval by the City.

# Submission Process

# Phase One Applicant Submittal Process

Applications for the Art Memorial for Tyrone Carney Park shall be uploaded to a secure Google Drive folder managed by the City. **Each applicant, upon request to the City's Project Manager, will be provided with an individual, secure folder link** that can only be accessed by the applicant and City staff. You do not need to have a Gmail account to access the Google Drive folder.

# Phase Two Finalist Submittal Process

Finalist applications for the Art Memorial for Tyrone Carney Park shall be uploaded to the same folder that the applicant used for the Phase One submittal.

The application must include the following:

- Artist Statement: Why are you interested in this project? Does this project resonate with you in some manner? Briefly describe your experience, philosophy and approach to public art.
- **Resume**: Submit a current resume that outlines your professional accomplishments as an artist along with a listing of completed public art projects, including final budgets. The resume must be a maximum of two pages (*applies to all team members*, *if applicable*).
- **Images of Past Work**: Submit ten (10) images of at least three projects of your past work that demonstrate your qualifications for this project.
- **Descriptions of Past Work**: <u>Submissions must also include a list of the images, including project sponsor/funder, location, date, media, dimensions, budget, and other essential information.</u>

#### Phase One Submission Deadline

Submissions must be received as a complete application no later than **Friday**, **Nov 18**, **2022**, **2:00 PM**, **Pacific Standard Time**. Incomplete, non-compliant and/or late submittals, and materials not specifically requested in this RFQ, will not be reviewed.

# **PUBLIC ART PROGRAM POLICIES**

# Acceptance of Proposals

The City reserves the right to reject all applications and/or subsequent design proposals.

# Maquette Policy

In the event that an artist or artist team is asked to develop a maquette or other conceptual design materials for a proposal, the following policy shall apply. The Public Art Program shall:

- At its sole discretion, have unconditional rights to own maquettes or other design materials produced as a part of this selection and/or commission process.
- Have the right to display and/or reproduce any maquettes or proposal commissioned, whether selected for implementation or not.
- Require that all concepts, proposals and/or maquettes submitted are original and unique.

# Americans with Disabilities Act

The selected artist(s) will be required to comply with the Americans with Disabilities Act in addition to related federal, state, and local codes and will be encouraged to develop artwork(s) sensitive to programmatic as well as physical accessibility issues.

# Other Requirements

The artist(s) selected and approved by the Public Art Advisory Committee shall be asked to enter into a contract with the landscape architect of the overall park improvement project. All proposed locations and concepts for artworks are subject to approval by the City and/or other representatives. Depending on the specific scope of the project, prior to the issuance and throughout the duration of the contract, the artist may be required to maintain various types of insurance, including Automobile Liability, General Liability, Fine Arts (if applicable), Workers' Compensation, and other insurance.

All information contained herein does not constitute either an expressed or implied contract and these provisions are subject to change.
