OAKLAND COMMUNITY POLICING ADVISORY BOARD

RESOLUTION NO. 10-12-22

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE COMMUNITY POLICING ADVISORY BOARD AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See* <https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-Coronavirus-SOE-Proclamation.pdf>

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See* <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html>;

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See* <https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html>;

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See* <https://www.cdc.gov/aging/covid19/covid19-older-adults.html>;

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19

symptoms stay home. See <https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html>;

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. See <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html>;

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. See <https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html>;

WHEREAS, the City's public-meeting facilities are indoor facilities that do not designed to ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; now therefore be it:

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to in-person meetings, thereby putting them in close and prolonged contact with additional people outside of their households; now therefore be it:

RESOLVED: that the Community Policing Advisory Board finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this Resolution; and be it

FURTHER RESOLVED: that, based on these determinations and consistent with federal, state and local health guidance, the Community Policing Advisory Board determines that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

FURTHER RESOLVED: that the Community Policing Advisory Board firmly believes that the community's health and safety seriously and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Community Policing Advisory Board will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Community Policing Advisory Board finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever is occurs first.


Please see Citywide and Police Area 3 Year-To-Date Crime Reports for the last available period. Additionally, please see year to date crime stats for Little Saigon, ending on September 15, 2022. This report focusses on incidents that have occurred west of the 2nd Ave, east of 12th Ave, north of E15th St, and south of E11th St (Little Saigon corridor).

January – May, of 2022, saw increased of overall crime (which include Shootings, Robberies, Auto Burglaries, Thefts, and Homicides) of 19% compared to the same period last year. Between Jan – Mar, crime was comparable, 54 crimes in 2021 and 53 crimes in 2022. In April 2022 there was 93% increase in crime, compared to the prior month (March 2022), and to April 2021. Even thou there was a decrease crime, the next month, of 26% in May, there was still an increase of 53% in comparison to May of 2021. An overtime assignment was created, in June 2022, that has been focusing on high visibility patrolling. Since deploying the overtime units in this area, June, July, August, has seen an average of 85% decrease, in comparison to the April (Highest month in crime for the year), and a 46% decrease in comparison to May (Second highest month in crime for the year).

3) Community Policing Projects and Updates

Project: Little Saigon and surrounding area

Background:

This project was created in June 2022 to address the alarming spike in crime in the area. Which included a homicide on 17 July 2022, in the 2000 block of 13th Ave and a homicide on 21 Augusts 2022, in the 1000 block of 5th Ave. The issues were identified as:

- The absence of officers in the area.
-
- Subjects driving into the area to commit violent crimes.

Services were provided in the following ways:

- Several press conferences were held by the Chief of police, council members, and community members in the area relaying to the community that OPD will be providing additional resources.
- Increase the staffing to the overtime assignment to provided additional high visibility patrolling in the area, seven day a week to cover the most active hours. With the focus on the below locations:
 - o 7th Ave and International
 - o 900 BLK of E12th St
 - o Clinton Park (655 International Blvd)
 - o 12th Ave and International Blvd
- An officer was appointed as the Little Saigon liaison officer (Ofc. Nguyen) for any additional needs or wants and better partnerships with the community.
- Intelligence-led investigative follow-up and enforcement. Let by CROs, along with the department's Violent Crime Operations Center officers, continued to identify suspects and develop operations to safely make arrests, identify suspect's through patrol and surveillance operations.

Updates:

On 23 Aug 22, CRO units were patrolling in the 1700 block of 13th Ave. They observed a older model Electric Blue Merc (Veh-1) that match a vehicle from a shooting, that had occurred on 18 Aug 22. A high-risk felony stop was conducted. The driver of the vehicle was placed in custody without incident. A search of Veh-1 yielded negative results.

CRO officers observed a Ford Explorer White (Veh-2) in color bearing parked near Veh-1. CRO officer observed a firearm in plain sight inside Veh-2. CRO officers conducted a PC search of Veh-2 which yielded the following:

- One (1) Black Rifle w/collapsible stock (Serial #AKA2318), One magazine w/unknown amount of 7.62mm ammo.
- One (1) Taurus Black/Green Pistol recovered loaded w/one in chamber (loose), one 17 round magazine

- One (1) Glock 26 loaded firearm with one in the chamber, 10 round magazine with unknown amount of ammunition inside.

- One (1) Large black bag of suspected marijuana.

- Several clear plastic sandwich bags containing suspected rock cocaine, meth, and Ecstasy.

The driver was arrested for various firearm and narcotics related charges. (RD#22-038553).



On 31 Aug 22, BFO-1 CROs collaborated with the VCOC, Intel, VICE and the ESU team to safely serve the Search Warrant of an Illegal Gambling Operation. Which resulted in officers locating the following:

- Four (x4) Semi-automatic firearms
- Approx. 15lbs. of suspected marijuana
- \$3000 US Currency
- 12 Gaming machines




On 3 Sep 22, OPD officer, working Little Saigon overtime, was directed by a gas station employee to vehicle where an individual was sleeping. The officers observed a firearm next to the individual. The individual woke up and began to drive away. The officers conducted a high risk stop and the individual was taken into custody without incident. Officers recovered a loaded firearm. (RD# 22-040418)

Violent Crime Operations Center (August 24th – September 15th)

Has made 9 significant arrest and have recovered 6 firearms.



September 2022 (As of the 15th) has had only 2 reported crimes in the area. Which is a 350% decreased compared to September 2021. And an 850% decrease on crime, on average per month this year.

Diversion programs are not yet in place.

The relationship between NSPC’s, and Little Saigon Community members has been outstanding in public safety assistance and educating the public. They have improved the way we communicate and collaborate with the community. We continue to have community meetings to answer any questions or ongoing concerns regarding public safety strategies moving forward. OPD (and the community) will only benefit further with more community engagement. If the CPAB has any insight on how to get more member of the community involved, OPD would be happy to partner with them. The safety of our community remains our number one focus.

With continued challenges with staffing, BFO1 community resource unit has been significantly reduced to address issues brought forth by neighborhood committees. We ask our community members to be patient with us and we understand that all concerns are important, and we are doing our best to address your concerns.







Day of Week Graph









Time of Day Graph









Successful Community Partnership

- In Beat 6X Hoover Durant has received clean-ups for the encampments located at 35-36th and MLK, and West Grand and MLK. This is really movement in the right direction for the community.
- Chair of 4X and the NSC reached out to the new luxury apartments to invite them to attend the September Neighborhood Council meeting. - 6X Hoover Durant partnership with OPD and MACRO to remove abandon car on Sycamore and provide the unsheltered services.
- Partnering with Environmental Stewardship Division to provide Bulky clean-ups in West Oakland.
- Citywide National Night Out coordination. It was a lot of fun meeting and enjoying the festivities each community provided. There were over three hundred National Night Out parties this year.

- In beats 18/19, 20X, 21XY, 23X 24X, & 27Y, the NSC is successfully partnering with non-profit and government agencies in Alameda County. Building a strong rapport with other professionals/agencies is an ongoing process. The NSC offers residents and Merchants non-profit and government resources when working in the field.
- In Beat 7X Public Works has added picking up old mattresses at the Mattress Guy's vacant business.
- In Beat 10Y the chair, Max Cadji welcomed a new resident from the East side of town to the North.
- NSC met with Ken Houston to begin conversations around beautification projects.
- Beats 27X, 27Y & 28 hosted an Emergency Preparedness Fair at Fremont High School. Various partners were in attendance to include the Red Cross, PG&E, Oakland Fire, Oakland PD, the library, East Bay MUD and the Animal Shelter.
- In Beat 31YZ there was a collaboration between Sobrante Park Resident Action Council, Eunice Law and Beat 31YZ. The Legacy continues and Lodestar Community School was to provide resources to families and students for the upcoming school year. The event was held on Saturday, July 30th on Lodestar's campus. There were over 3000 participants, 40+ vendors, 1,000 meals served courtesy of Mobilize Love and over 2,000 backpacks with school supplies were distributed to students. As usual, vendors came prepared and the participants left with bags full of needed items and information. The Oakland Zoo was a big surprise for the kids. The event was better than we could have ever imagined.

Beats with challenging projects

- In Beat 6X Hoover Durant homeless encampments are overflowing on MLK and under the freeway.
- In Beat 2X/5X Acorn & Oak have abandoned cars, unsheltered are now trespassing on to private property to use the resident's utilities.
- In Beat 7X Alliance Recycling is operating a diesel generator for an illegal cannabis operation. Greg Minor, Law Corp Attorney A. Phillips, and the NSC are working on the issue in partnership.
- In Beat 18/19, 20X, 21XY, 23X, 24X & 27Y the Neighborhood Services Coordinator has been working with the City and community agencies to establish a resource center within the Fruitvale community. Creating a resource center within the community will enhance the presence of the NSC and OPD. This in turn will help aide in the demand for public safety. This is what the community is demanding.

- In Beat 24Y the CRO, NSC, Code Enforcement and Vehicle Abatement have been working on a problem property on Humboldt that needs to have exterior blight and vehicles removed from the property.
- In Beat 27X, the NC, OPD and NSC is working with the Code Inspector to board and secure a vacant property that has been red tagged as inhabitable.
- In Beat 29, a property on Fleming Avenue continues to be a problem for the neighbors. This residence has been identified as a known chop shop. Code Enforcement, OPD, NSC and the Neighborhood Watch group have all been working on this property to abate the problems.

Community Project (Complete or in Progress)

- In Beat 6X, Hoover Durant & 2X/5X Acorn & Oak an abandoned car sweep organized by Captain Burch made the residents happy. The community has been waiting for this enforcement effort. (In progress)
- In Beat 6X, Hoover-Durant, 29th & MLK, the street lights are not functioning. The Encampment Management Team (EMT) has scheduled a date for repair. (In progress)
- Citywide, a common theme is that neighborhoods suffer from abandoned vehicles, illegal dumping and crime. (In progress)
- Citywide, neighborhoods want to see a greater presence of Oakland Police Officers to address public safety issues. In addition, resource centers throughout the City will allow for greater access to programs, vital information, and assistance to our most vulnerable populations. (In progress)
- In Beat 30/x, the NC is working with the City's NEST team to prioritize service delivery and access to programming in and around Arroyo Viejo Park. With Oakland Public Library and the Police Department, they recently hosted an ice-cream social and community meeting that brought new neighbors from 2 blocks immediately around the park into direct conversation about how to improve the area. (In progress)
- In Beat 35X, the NC has advocated for speed bumps to be added to Golf Links Road. In an exciting update from the Department of Transportation, speed bumps will be installed on Golf Links Road between Fontaine and 98th in the upcoming year. (In progress)
