Re: **Proposal to Restore Crossing Guards**

Dear Colleagues on the City Council and Members of the Public,

School Crossing Guards play a vital role in the lives of children and families who walk or bike to school and are an important part of our communities. There are over 150 schools in the City of Oakland, with 52 of them having crossing guards in 67 established Crossing Guard posts. In the administration's FY 2021-23 budget plan, they propose to cut 13.5 FTE crossing guards, which total about 30 part-time positions. At a time where we have seen an increase in unsafe driving on our streets, and with children returning back to the classroom, we must keep these crossing guard positions around our schools and ensure the safety of our children and their families.

Crossing guards not only help children safely cross the street on their way to and from school, but also play other important roles in preventing accidents and other hazards. This includes: discouraging children and other pedestrians from behaving unsafely near traffic; creating gaps to allow for crossing by stopping traffic temporarily; alerting motorists that pedestrians are in the process of using the school crossing; and, observing and reporting any conditions that present a potential safety hazard. In addition, the presence of these trusted adults, including their role as eyes on surrounding activity, tends to deter and reduce other risks to our children, including crime, bullying and other problems. The mayor's proposal to eliminate numerous crossing guards would move our city in the wrong direction, and worsen risks for our children.

In addition to acting as a safeguard to children, crossing guards are typically community members who develop relationships with children, parents, guardians, and others who walk or bike. These budget cuts would mean these crossing guards would lose their source of income.

Upon hearing of the proposed cuts, I worked to seek methods to restore these vital positions. Fortunately, Oakland receives funding from countywide transportation taxes which we had worked previously to successfully pass by the voters. These Measures, B and BB, provide funding to Oakland through a formula based on sales tax revenue. Fortunately, this sales tax revenue has come in above prior projections in the current fiscal year. There is over \$900,000 in additional revenue in each Measure. Therefore, we are proposing to restore the crossing guards, without needing to cut any other proposed items, by allocating the extra, previously unbudgeted revenue in Measure B this year, and using it to fully fund the crossing guards in the upcoming two year budget. We must invest in our children, families, and workers during this critical time. I ask you to join me in saving these crossing guard positions. Please see the attached spreadsheet.
