## **AFFORDABLE HOUSING & INFRASTRUCTURE BOND PUBLIC OVERSIGHT COMMITTEE**

The Affordable Housing & Infrastructure Bond Public Oversight Committee will review relevant financial and operational reports related to the expenditure of Affordable Housing & Infrastructure (Measure KK, 2016) bond proceeds and provide reports to the City Council when necessary and evaluate the impacts and outcomes of bond expenditures on the bond measure's stated goals, including social equity, anti-displacement and affordable housing.

The Committee will be comprised of nine members appointed by the Mayor and subject to confirmation by the City Council. The Mayor is seeking individuals who will representative the diversity of Oakland, including Oakland residents of low income communities of color, individuals with experience in financial management, fiscal audits, environmental justice, capital planning, infrastructure improvement, and affordable housing.

The Public Oversight Committee shall meet at least XX times per fiscal year.

## BICYCLIST & PEDESTRIAN ADVISORY COMMISSION

Oakland's Bicyclist & Pedestrian Advisory Commission (BPAC) was established in 2014 to advise the City Council on plans, policies, projects, and programs that affect walking and bicycling. In September 2014, the Commission replaced the Bicycle & Pedestrian Advisory Committee, a body formed by the Public Works Department that had met monthly since 1994.

Oakland residents interested in serving on the Commission are encouraged to apply by mid-September this year. The nine-member commission has staggered terms such that three commissioners' terms end December 31 of each year. The BPAC reviews applications and makes recommendations to the Mayor. The Mayor proposes candidates that must be confirmed by City Council, with new terms and commissioners starting each January.

Commissioners must take the Oath of Office and submit Conflict of Interest Filings (Form 700) at the time of assuming office, annually by April 1, and within 30 days of separation from this body. Commissioners cannot serve more than 6 years.

## **CANNABIS REGULATORY COMMISSION**

On November 2, 2004, the Oakland electorate passed ballot Measure Z, a voter initiative entitled "Oakland Cannabis Regulation and Revenue Ordinance". The ordinance requires the City of Oakland (1) Make investigation, citation and arrest for private adult cannabis (marijuana) offenses the City's lowest law enforcement priority; (2) Advocate through its lobbyist and City officers for changes in state and other laws to (a) allow and authorize taxation and regulation of cannabis (marijuana) for adults and eliminate criminal penalties for private, adult cannabis use, (b) grant local control to cities and counties to license and regulate cannabis businesses and collect appropriate fees and taxes, and (c) end the prosecution arrest, investigation and imprisonment for adult private cannabis offenses; (3) Establish a system to license, tax and regulate cannabis (marijuana) sales if California law is amended to allow and authorize such actions; and (4) Create a committee to oversee the ordinance's implementation and disbursement of revenue from licensing and taxation of businesses that sell cannabis.

Each Council member shall appoint a community member. The committee shall also include a representative of the City Administrator and City Auditor. Members shall be appointed to a term of two years, and said terms shall commence upon the first day of August 2005, except that an appointment to fill a vacancy shall be for the unexpired term only. Members may be re-appointed to subsequent terms

## COMMUNITY POLICING ADVISORY BOARD

The Cultural Affairs Commission is an advisory body to the Mayor, City Council, and City Administrator on matters affecting cultural development in Oakland. The Commission acts as ambassadors and advocates for arts and culture in the city.

The Cultural Affairs Commission will be comprised of 11 commissioners: 10 regular appointments and 1 appointment selected from the Public Art Advisory Committee.

## **OAKLAND ANIMAL SERVICES COMMUNITY ADVISORY COMMISSION**

The Oakland Animal Services Community Advisory Committee provides City staff with professional advice, technical assistance, guidance, insight and recommendations about best practices regarding the OAS. The Advisory Committee focuses on three, key operational areas:

Animal health, care and welfare;

Animal rescue: operational improvements, approaches to increase rescues and live release, potential partnership opportunities; and,

Euthanasia: reductions and operational improvements.

The scope of the Committee's work and recommendations are limited to addressing policy development or changes, operational improvements, and facility and equipment/ technology enhancements. The Committee does not address personnel-related matters or provide specific management direction. They can provide advice as it pertains to recommendations in the areas described above. The Community Advisory Committee will also review draft policies and procedures regarding shelter operations and recommend changes to ensure that they reflect best practices in the animal welfare industry.

All members of the Animal Services Commission shall be persons who have demonstrated their compassion for animals and who have experience in animal welfare. Members of the Animal Services Commission shall represent the following animal welfare categories, with no more than two (2) members representing any particular category:

(1) a licensed veterinarian, preferably one with public shelter experience;

(2) an individual with significant experience volunteering at a public animal shelter;

(3) an individual representing a public animal shelter;

(4) an individual representing a private animal shelter;

(5) an individual representing private, not for profit or non-profit animal rescue organizations;

(6) an Oakland resident who is representative of the Oakland community and who can provide outreach within the areas of Oakland with the highest concentration of need for animal shelter care and services.

No member may be employed by Oakland Animal Services or have any financial interest, employment, or policy-making position in any commercial or for-profit animal care facility, research center, or other organization that sells animals, including breeding, sales and research; or profit from decisions made by the Commission. Veterinarians are excluded from this prohibition.

Members of this Board may be subject to filing requirements of Form 700.

## OAKLAND WORKFORCE DEVELOPMENT BOARD

The Workforce Innovation and Opportunity Act of 2014 ("WIOA") replaced and superseded that Workforce Investment Act of 1998 ("WIA"). The Oakland Workforce Investment Board ("WIB") was created pursuant to WIA in 1999. Section 107 of WIOA provides for the establishment of a new local workforce development board in each local workforce development area to replace the WIA workforce investment board in carrying out certain designated workforce development functions. Section 679.310(g) of the proposed WIOA regulations requires the chief local official of a local area to establish bylaws for the workforce development board consistent with state policy for board membership.

As mandated by the Workforce Innovation and Opportunity Act (WIOA), on March 31, 2016, by Executive Order, and as Chief Local Elected Official of the Local Area Designation (the City of Oakland), Mayor Libby Schaaf disbanded the former Workforce Investment Board (WIB) and established the new Workforce Development Board (WDB). The Oakland WDB oversees the federally-funded employment and training programs and services in Oakland. These programs and services help job seekers gain employment and connect businesses with a qualified workforce.

The Mayor appoints the board positions on the Oakland WDB. A majority of these positions are reserved for business-sector leaders. The Oakland WDB can have up to 27 members. Generally speaking, the Mayor and the WDB share equal authority according to the federal legislation. The Oakland City Council authorizes the City Administrator to appropriate funding and enter into contracts with service providers.

## POLICE COMMISSION

The Police Commission is comprised of seven regular and two alternate members. All commissioners are Oakland residents and serve in a volunteer capacity. The purpose of the Police Commission is to oversee the Oakland Police Department's policies, practices and customs to meet national standards of constitutional policing and to oversee the Community Police Review Agency that investigates police misconduct and recommends discipline.

The City Council can approve policy that furthers the goals of Measure LL. At the City Council meeting on July 18, 2017, the Council provided direction to the City Administrator regarding a draft ordinance that (1) enables implementation of the City Charter amendment creating the Oakland Police Commission and the Community Police Review Agency, (2) establishes a civilian Inspector General, and (3) requires an annual report and presentation by the Community Policing Advisory Board to the Police Commission. The draft ordinance will return to the Council for discussion at a future date to be determined.

## **PUBLIC ART ADVISORY COMMITTEE**

The Public Art Advisory Committee works with staff to develop program policies and procedures and approves sites, budgets, selection methods, and proposals for public art in Oakland. The committee advises the City Administrator, Mayor, and City Council on all matters pertaining to public art in Oakland. The Public Art Advisory Committee is a subcommittee of the Cultural Affairs Commission. The Advisory Committee works with City staff to develop Oakland's public art program and keep it running smoothly. Members are appointed by the Mayor and approved by City Council.

In 1989 the City of Oakland adopted a Public Art Ordinance (11086 C.M.S.) and an Oakland Redevelopment Agency resolution (89-8 C.M.S.) for a "Percent for Art Ordinance" plan which authorizes the allocation of 1.5% of municipal capital improvement project costs for commissioning of public artwork. These monies are set aside in the Public Art Program Fund.
