I am interested in joining the Bicyclist and Pedestrian Advisory Commission to help the city continue its work in becoming a world-class city for bicyclists and pedestrians in every neighborhood. I believe Oakland should ensure resources are invested in underserved communities equitably, and that planners and commissioners should engage with those residents to develop sensible and meaningful bike and pedestrian plans appropriate for their neighborhoods. I also believe the city should be a leader in piloting innovative infrastructure treatments—like the green bike lanes on 40th Street—so the Bay Area, California, and the nation can look to us for effective solutions.

I am a PhD candidate at UC Berkeley in the Department of City and Regional Planning. My primary area of research is in the domains of bicycling and transportation equity. I am the research coordinator for a project that will survey low-income immigrants in Alameda County to better understand some of the barriers and constraints they face in deciding to ride their bikes for daily trips. The goal of the project is to be able to provide meaningful information to transportation planners on how they might suggest policy that ensures immigrant bicyclists' needs are being met equitably. I have conducted other studies that examined bicycle safety in the County and significant factors that lead to bicycling to BART. Outside of professional work, I have volunteered to assist WOBO with the Oaklavia event in 2013. Prior to moving to the Bay Area, I was a member of the Los Angeles County Bicycle Coalition. I believe my training in research on bicycling issues plus volunteering for bike and pedestrian causes makes me an ideal candidate for the Bicyclist and Pedestrian Advisory Commission.

Please state your past and current professional experience and community involvement with bicyclist and or pedestrian issues (200 words or less).

In 2007, I began a full-time internship with the San Francisco Bicycle Coalition (SFBC). While with the SFBC, I was heavily involved in coordinating city-wide outreach campaigns focused on "closing the gaps" in San Francisco's bicycle network.

From 2009 - 2011, I served on the Board of Directors of Walk Oakland Bike Oakland (WOBO) - a nonprofit organization dedicated to making Oakland a safer, more convenient and enjoyable place to bike and walk. During my tenure, I conducted outreach across Oakland and worked with community stakeholders to organize events such as Oaklavia and Bike To Work Day.

It was during this time that I helped organize and launch the very first East Bay Bike Party - a group bicycle ride that is now several years old and attracts up to a thousand riders each month.

From 2008 - 2012, I worked for City CarShare - a Bay Area nonprofit devoted to providing convenient, affordable acces to shared cars in an effort to reduce individual auto dependence and improve the environment and overall quality of life in the Bay Area. My job was an active one: traversing the Bay Area via bicycle to help maintain a fleet of 300+ vehicles.

Currently, I am a proud owner and operator of Pedal Express - the East Bay's only biycle courier service. We provide a sustainable delivery option for city governments, merchants and residents in Oakland, Berkeley and Emeryville. All deliveries are made exclusively by bicycle.

Please provide a statement of interest in serving on the Bicyclist and Pedestrian Advisory Commission (200 words or less).

I would like to be a member of the new City of Oakland Bicyclist and Pedestrian Advisory Commission. I am a resident of North Oakland near the Caldecott Tunnel. Recently, I served the City of Oakland as a member of the Parks and Recreation Advisory Committee. As my term has expired, I am looking for other methods to serve my city.

I regularly bike and walk in Oakland. I bike the hills of Oakland and then ride to downtown. I might cycle a 1000 miles a year. I regularly walk around Lake Merritt and the waterfront. From these efforts, I know of several areas that Oakland could improve that will help the Bicycle and Pedestrian community. It is vital to make these changes so our city can be even more livable.

I have been working on bicycle and pedestrian ideas near my home in Oakland since the 1990s. I have worked with Caltrans and the AACMA on implementing these ideas. It has been a long effort, but the efforts are now succeeding.

I am an officer of the Caldecott Tunnel Fourth Bore Coalition. Its mission is to improve the infrastructure of cycling and pedestrians using funds from the recent Caltrans settlement.

Please state your past and current professional experience and community involvement with bicyclist and or pedestrian issues (200 words or less).

I have created specific ideas on how to improve pedestrian and bike paths. These projects are currently being built and construction will shortly start.

Unfortunately, due to the limitations of the budget, some ideas could not be implemented. These items are still needed and I want to advocate their completion.

For instance, many years the Landsville Bridge joined the regions. When Highway 24 was built, our neighborhoods were severed. Currently, the walking and biking path requires pedestrians and cyclists to go up a steep hill. This path adds about two miles of extra length. The Caldecott Settlement provides funding for a study on the best way to implement a direct route. After the study is finished, the next step would be to get funding for the project. It would take advocacy of the Bicyclist and Pedestrian group to get funding for the new path.

The importance of this effort is to provide a way to join our neighborhood in North Oakland to the Montclair district. If this would be done, people can traverse the regions without a car. Now it is time, to find a way that the fissure can be closed and pedestrians and cyclists can transverse the neighborhoods.

Please provide a statement of interest in serving on the Bicyclist and Pedestrian Advisory Commission (200 words or less).

Human-powered transportation is important: reduced vehicle emissions, more efficient land use consumption, public health, etc. But the reason that most compels me to walk and bike is a basic preference for enjoyable spaces. I love living in a walkable neighborhood. I appreciate that I live in a welcoming community when I run into neighbors on the street. I like impressing visitors with a walk around Lake Merritt.

As a transportation safety professional, student, and now general enthusiast, I am excited to be in Oakland. We have a fair share of challenges, but also the kind of city staff and engaged residents that can make a positive difference. We have a very active bicycle community, that I'm pleased to be a part of, and while I own a car, I chiefly identify as a pedestrian. It is important for the BPAC to have a specific voice for downtown pedestrian safety. Past design choices (think: ramps at Broadway and 7th) create unsafe areas that stifle economic development (in that case, Jack London).

If selected to serve on the BPAC, I would bring my training in technical analysis (MIT) and design (UC Berkeley) to make Oakland a more welcoming place to explore on foot.

Please state your past and current professional experience and community involvement with bicyclist and or pedestrian issues (200 words or less).

I became active in Oakland's bicycle and pedestrian advocacy community in 2010, when I began a year-long, full-time volunteer fellowship with Walk Oakland Bike Oakland (WOBO). Before that, I worked at Cambridge Systematics, Inc. (an international transportation consulting firm), where I focused on transportation safety. At WOBO, I led our policy committee, and steered several campaigns, including ones for a city-wide parklet pilot and crosswalk policy. During this year, I was a member of Oakland's Bicycle and Pedestrian Committee. I left WOBO a year later to enroll in the Master of City Planning program at the University of California, Berkeley, where I focused much of my research on accessible and successful downtown areas. I am an avid cyclist and walker, so applying to serve on the commission feels natural. I have been active in Oakland and East Bay cycling organizations since my wife and I moved to Oakland after my retirement in 2010. As senior citizens with two children and two grandchildren living in Oakland, we represent three generations of cyclists and walkers.

Cycling and walking contribute positively to a sustainable environment. Because of the threats carbon emissions pose to our climate, thousands of environmentally-conscious people have already turned to cycling and walking for commuting, recreational, and personal trips. The challenge for Oakland is to provide safe and convenient routes to facilitate this movement toward self-locomotion.

Oakland is already a bicycle-friendly city with the ability to achieve a gold or even platinum standard rating from the League of American Bicyclists.
