Mountain View Cemetery is located at 5000 Piedmont **Avenue, in Oakland and Piedmont**. The project includes an expansion of the cemetery use (within the existing cemetery property) involving grading, tree removal, landscaping (including planting new trees) and features such as niche walls, outdoor amphitheater seating, pathways, and grave site areas.
