## **INFORMATION**

Effective July 1, 2016, all customers receiving Zero Waste Services from California Waste Solutions (CWS) and Waste Management of Alameda County (WMAC) will see an increase in their rates. This is an annual rate adjustment provided for in the contracts with the two companies. The increases are comprised of an indexed-base annual adjustment and additional approved adjustments that recover the costs of:

- Deferring the Consumer Price Index (CPI) adjustment in the first year of the contract;
- Providing lower initial rates in first year of the contract; and
- Increasing wages and benefits for recycling sorters represented by ILWU Local 6.

Table 1 shows the current rates, the rates effective July 1, and the amount of the increases for representative service levels in the three service sectors.

### **Customer Notification**

All customers will be notified of the July 1 changes to the Zero Waste Services rates through postcards (attached) that will be mailed in early June 2016. The postcards will direct the reader to the complete rate tables that are posted on OaklandRecycles.com. A two-fold bill insert, similar to those prepared for July 1 in years past, will provide similar information. A full page

advertisement and article about services to multi-unit residential buildings will appear in the June edition of the East Bay Rental Housing Association magazine.

The total rate impact of the combined rate component adjustments are shown in Table 2.

<sup>&</sup>lt;sup>1</sup> Rate impact shown applies to 32-gallon service level only, the rate increase ranges from 10.65% for 20-gal to 8.33% for 96-gal due to the effect of recycling rates, which are set per household rather than by volume. <sup>2</sup>Rate impact may be less depending on service level.

## **Annual Rate Adjustment**

The annual rate adjustment, also called the Refuse Rate Index, is based on indices specific to the recycling and waste industry including fuel, fleet maintenance and replacement, and changes to union labor and benefits. This year the maximum annual rate adjustment was 2.1 percent.

## **Approved Additional Rate Adjustments**

Table 3 below shows the timeline for when three additional rate adjustments will sunset. After these dates, customers' bills will reflect only the annual rate adjustment.

#### **Commercial Organics Rate**

Commercial organics rates were set at 30 percent below commercial garbage rates effective October 1, 2015, and will be lowered to 25 percent below commercial garbage rates effective July 1, 2016. The impact of this change, in combination with the commercial garbage rate adjustment, results in an increase of 14.9 percent to the commercial organics rates, as noted in Table 2 above.

For reference, the rate adjustment methodology and the additional adjustments were approved by City Council through:

- Ordinance No. 13254 C.M.S., which granted a franchise for Residential Recycling Collection Services to CWS;
- Ordinance No. 13258 C.M.S., which amended Ordinance No. 13253 C.M.S. to grant a franchise for mixed materials and organics collection services to WMAC, and approved maximum service rates for mixed materials and organics collection, residential recycling and disposal services; and
- Ordinance No. 13331 C.M.S., which amended Ordinance No. 13258 C.M.S., to set maximum commercial organics rates and add rates that were missing from the rate tables approved in the latter ordinance.
